1 AN ACT concerning administrative rules and regulations; requiring state  
2 agencies to provide notice of revocation thereof; removing certain  
3 abolished or inactive state agencies from the five-year state agency  
4 review requirement; amending K.S.A. 2023 Supp. 77-426 and 77-440  
5 and repealing the existing sections.  
6

7 *Be it enacted by the Legislature of the State of Kansas:*

8 Section 1. K.S.A. 2023 Supp. 77-426 is hereby amended to read as  
9 follows: 77-426. (a) All rules and regulations that are in force and effect at  
10 the time this act takes effect shall continue in full force and effect and may  
11 be amended, revived or revoked as provided by law. All new rules and  
12 regulations and all amendments, revivals or revocations of rules and  
13 regulations, other than temporary regulations, adopted in any year shall be  
14 filed with the secretary of state and shall become effective 15 days  
15 following its publication in the Kansas register or such later date as clearly  
16 expressed in the body of such rule and regulation.

17 (b) Except for rules and regulations revoked pursuant to subsection  
18 (d), as soon as possible after the filing of any rules and regulations by a  
19 state agency, the secretary of state shall submit to the joint committee on  
20 administrative rules and regulations such number of copies as may be  
21 requested by the joint committee on administrative rules and regulations.

22 (c) At any time prior to adjournment sine die of the regular session of  
23 the legislature, the legislature may adopt a concurrent resolution  
24 expressing the concern of the legislature with any permanent or temporary  
25 rule and regulation that is in force and effect and on file in the office of the  
26 secretary of state and any permanent rule and regulation filed in the office  
27 of the secretary of state during the preceding year and requesting the  
28 revocation of any such rule and regulation or the amendment of any such  
29 rule and regulation in the manner specified in such resolution.

30 (d) (1) Notwithstanding any other provision of the rules and  
31 regulations filing act, any rule and regulation may be revoked pursuant to  
32 this subsection if such rule and regulation is identified by a state agency in  
33 the report submitted to the joint committee on administrative rules and  
34 regulations pursuant to K.S.A. 2023 Supp. 77-440, and amendments  
35 thereto, as one that may be revoked pursuant to this subsection. A state

1 agency may revoke a rule and regulation by filing a notice of such  
2 revocation with the secretary of state and causing such notice to be  
3 published in the Kansas register. Such notice of revocation shall not  
4 contain any new rules and regulations or any amendments to any rules and  
5 regulations.

6 (2) Prior to filing the notice of revocation with the secretary, the state  
7 agency shall:

8 (A) *Provide a written notice to ~~affected~~ businesses, local*  
9 *governmental units and members of the public ~~of~~ **{known to the agency to***  
10 ***be affected by}** the proposed revocation. Upon the written request of a*  
11 *member of the public, hold a public hearing on the proposed notice of*  
12 *revocation;*

13 (B) ~~submit the notice of rules and regulations proposed for~~  
14 ~~revocation to the attorney general for review and approval in accordance~~  
15 ~~with K.S.A. 77-420(d), and amendments thereto; and~~

16 (C) submit the notice of revocation to the joint committee on  
17 administrative rules and regulations and, upon request by the chairperson  
18 of such committee, appear before such committee at a hearing on such  
19 notice.

20 (3) The revocation of a rule and regulation under this subsection shall  
21 be effective 15 days following the date that the notice of such revocation is  
22 published in the Kansas register.

23 Sec. 2. K.S.A. 2023 Supp. 77-440 is hereby amended to read as  
24 follows: 77-440. (a) All rules and regulations adopted by state agencies  
25 under the provisions of K.S.A. 77-415 et seq., and amendments thereto,  
26 shall be reviewed every five years in accordance with this section.

27 (b) (1) Each state agency that has adopted rules and regulations shall  
28 submit a report to the joint committee on administrative rules and  
29 regulations on or before July 15 of the year that corresponds to such state  
30 agency under paragraph (2). Such report shall contain a summary of such  
31 state agency's review and evaluation of rules and regulations adopted by  
32 such state agency, including a statement for each rule and regulation as to  
33 whether such rule and regulation is necessary for the implementation and  
34 administration of state law or may be revoked pursuant to K.S.A. 77-  
35 426(d), and amendments thereto.

36 (2) Each state agency that has adopted rules and regulations shall  
37 submit a report as required under paragraph (1) in the years that  
38 correspond to such state agency as follows:

39 (A) For 2023 and every ~~fourth~~ 5<sup>th</sup> year thereafter, the following state

3       (c) For any state agency not listed in subsection (b)(2) that adopts  
4 rules and regulations that become effective on or after July 1, 2022, such  
5 state agency shall submit a report to the joint committee on administrative  
6 rules and regulations in accordance with subsection (b)(1) on or before  
7 July 15 of the ~~first~~ 5<sup>th</sup> year after such rules and regulations become  
8 effective and every ~~first~~ 5<sup>th</sup> year thereafter.

9       (d) Notwithstanding any other provision of law, a rule and regulation  
10 may be adopted or maintained by a state agency only if such rule and  
11 regulation serves an identifiable public purpose to support state law and  
12 may not be broader than is necessary to meet such public purpose.

13       (e) This section shall be a part of and supplemental to the rules and  
14 regulations filing act, K.S.A. 77-415 et seq., and amendments thereto.

15       Sec. 3. K.S.A. 2023 Supp. 77-426 and 77-440 are hereby repealed.

16       Sec. 4. This act shall take effect and be in force from and after its  
17 publication in the ~~statute book~~ {*Kansas register*}.
