HB 2583–Relating to offender registrant admittance to or residence within an adult care home.

HB 2697–Relating to collateral assignment of the proceeds of life insurance policies.

HB 2656–Relating to the transfer of adult protective services from the department of social and rehabilitative services to the office of attorney general.

Katherine McBride refreshed the committee on **HB 2656**.

There were many questions and comments made by Rep. Wolfe, Rep. Gonzalez, Rep. LeDoux, Rep. Otto and Rep. Flaharty.

*Rep. Otto made a motion to table **HB 2656**. The motion was seconded by Rep. Hill. Chairman Bethell asked for a vote and the motion carries.* Rep. LeDoux asked to go on record as being opposed to the motion.
