Chairperson Pottorff called the meeting to order and thanked Haley DaVee (Kansas Credit Union Association) for the lunch.

The minutes for the December 15, 2010, meeting were approved. (Motion by Representative Wolf; seconded by Senator Francisco)

The Chairperson welcomed Richard Gaito, Deputy Director, Division of Facilities Management, Kansas Department of Administration. Mr. Gaito reviewed a proposed lease in Lawrence by the Driver's License Bureau of the Kansas Department of Revenue (Attachment 1). He said that the first Request for Proposal (RFP) produced two proposals, both of which were too costly. The second RFP yielded four proposals from three bidders, the lowest of which was deemed to be an undesirable location. The lease presented was a five-year lease at \$9.23 per square foot (psf), a reduction of \$1.25 psf from the previous lease. Taxes, insurance, major maintenance, and parking are included in the base rate. If a second five-year-lease option is exercised, the cost increases to \$10.23 psf. Mr. Gaito said an energy performance audit rated the building at 72, which is 24 percent below the national average. He noted that the employee space was within recommended standards, but the license exam space exceeded space standards.

The lease was approved. (Motion by Senator Umbarger and seconded by Senator Francisco)

Aaron Klaassen, Kansas Legislative Research Department, reviewed information from a previous meeting regarding the Kansas Bureau of Investigation (KBI) capital improvements budget showing zero funding. Mr. Klaassen reported that, in FY 2007 and FY 2008, the KBI received \$100,000 annually for rehabilitation and repair. The amount initially was reduced to \$50,000 in FY 2009, prior to the budgeted funds being eliminated. It was noted that the Senate Ways and Means Committee had inserted \$100,000 into the KBI FY 2012 budget for a new generator, but the House Appropriations Committee did not concur. Robert Blecha. Director. KBI, stated that the current generator is 25 years old, well past its life expectancy, and that a backup generator is critical for maintaining statewide law enforcement services. He stated that, since no capital improvements funds were allocated to the KBI, any costs for other repairs would be met from existing funds.

Committee members discussed the need to address fire-prone lights at the Kansas Historical Society Museum in Topeka. It was noted that the Senate Ways and Means Committee included \$50,000 in the agency's FY 2012 budget to remediate this hazard. Committee members agreed to revisit the issue at the Committee's sine die meeting.
