1 AN ACT concerning education; relating to the financing thereof; relating
2 to the Kansas school equity and enhancement act; **making and**
3 **concerning appropriations for the fiscal year ending June 30, 2019,**
4 **for the department of education;** amending K.S.A. 2017 Supp. 72-
5 5132, 72-5133, 72-5143, 72-5145, 72-5148, 72-5149, 72-5150, 72-
6 5151, 72-5155, **72-5170, 72-5171, 72-5173,** 72-53,113~~and, 72-53,116~~

12 *Be it enacted by the Legislature of the State of Kansas:*

13 **Section 1.**

14 **DEPARTMENT OF EDUCATION**

15 (a) There is appropriated for the above agency from the state
16 general fund for the fiscal year ending June 30, 2019, the following:

17 **Operating expenditures**

18 (including official hospitality) (652-00-1000-0053).....\$15,000

19 *Provided,* That during the fiscal year ending June 30, 2019, in addition
20 to the other purposes for which expenditures may be made by the
21 above agency from moneys appropriated for the operating
22 expenditures (including official hospitality) account for fiscal year
23 2019 by chapter 95 or 104 of the 2017 Session Laws of Kansas, this or
24 any other appropriation act of the 2018 regular session of the
25 legislature, expenditures shall be made by the above agency to
26 implement the jobs for America's graduates - Kansas pilot program:
27 *Provided further,* That such program shall select a total of 75 students
28 for participation in the program with 25 students selected from the
29 Wichita school district (U.S.D. no. 259), 25 students selected from the
30 Topeka school district (U.S.D. no. 501) and 25 students selected from
31 the Kansas City school district (U.S.D. no. 500): *And provided further,*
32 That students shall be selected for participation in the program on or
33 before September 20, 2018: *And provided further,* That the selected
34 students shall enroll in and attend classes at schools operated by such

1 student's resident school district for ½ of such student's total school
 2 attendance, and shall enroll in classes provided by a virtual school
 3 operated by the southeast Kansas education service center -
 4 Greenbush for the remaining ½ of such student's total school
 5 attendance: *And provided further*, That expenditures shall be made in
 6 an amount not to exceed \$15,000 to acquire laptop computer devices
 7 for use by students participating in such pilot program.

 22 establishing collaborative relationships with community mental health
 23 centers, including a pilot program for school districts and their

27 ~~Provided, That expenditures shall be made by the above agency to
 28 implement the mental health intervention team pilot program so as to
 29 improve social-emotional wellness and outcomes for students by

 31 psychologists statewide: Provided, That school districts participating
 32 in such program shall enter into the necessary memorandums of
 33 understanding and other necessary agreements with participating
 34 community mental health centers and the appropriate state agencies
 35 to implement the pilot program: Provided further, That mental health
 36 intervention teams shall consist of school liaisons employed by the
 37 participating school district, and clinical therapists and case managers

 6 the director of the legislative research department the aggregate
 7 amount of expenditures for fiscal year 2019 for treatment and services
 8 for students provided under the mental health intervention team pilot
 9 program, or provided based on a referral from such program.

 17 commissioner of education that the necessary memorandums of
 18 understanding have been executed between the participating school
 19 districts and community mental health centers to implement the
 20 mental health intervention team pilot program, the director of
 21 accounts and reports shall transfer \$1,541,050 from the mental health
 22 intervention pilot program account in the state general fund of the
 23 department of education to the community mental health center
 24 improvement fund of the department for aging and disability services:
 25 Provided, That moneys transferred pursuant to this subsection shall
 26 be expended to provide treatment and services for students under the
 27 mental health intervention team pilot program who are uninsured or
 28 underinsured.}

 30 5132 is hereby amended to read as follows: 72-5132. As used in the
 31 Kansas school equity and enhancement act, K.S.A. 2017 Supp. 72-5131 et
 32 seq., and amendments thereto:

33 (a) "Adjusted enrollment" means the enrollment of a school district
 34 adjusted by adding the following weightings, if any, to the enrollment of a
 35 school district: At-risk student weighting; bilingual weighting; career
 36 technical education weighting; ~~declining enrollment weighting~~; high-
 37 density at-risk student weighting; high enrollment weighting; low
 38 enrollment weighting; school facilities weighting; ancillary school
 39 facilities weighting; cost-of-living weighting; special education and related
 40 services weighting; and transportation weighting.

41 (b) "Ancillary school facilities weighting" means an addend
 42 component assigned to the enrollment of school districts pursuant to
 43 K.S.A. 2017 Supp. 72-5158, and amendments thereto, on the basis of costs

1 attributable to commencing operation of one or more new school facilities
2 by such school districts.

3 (c) (1) "At-risk student" means a student who is eligible for free
4 meals under the national school lunch act, and who is enrolled in a school
5 district that maintains an approved at-risk student assistance program.

6 (2) The term "at-risk student" shall not include any student enrolled
7 in any of the grades one through 12 who is in attendance less than full
8 time, or any student who is over 19 years of age. The provisions of this
9 paragraph shall not apply to any student who has an individualized
10 education program.

11 (d) "At-risk student weighting" means an addend component assigned
12 to the enrollment of school districts pursuant to K.S.A. 2017 Supp. 72-
13 5151(a), and amendments thereto, on the basis of costs attributable to the
14 maintenance of at-risk educational programs by such school districts.

15 (e) "Base aid for student excellence" or "BASE aid" means an amount
16 appropriated by the legislature in a fiscal year for the designated year. The
17 amount of BASE aid shall be as follows:

18 (1) For school year ~~2017-2018, \$4,006~~ **2018-2019, \$4,170;**

19 (2) for school year ~~2018-2019, \$4,128~~ **2019-2020, \$4,307;**

20 **(3) for school year 2020-2021, \$4,444;**

21 **(4) for school year 2021-2022, \$4,581;**

22 **(5) for school year 2022-2023, \$4,718;** and

23 ~~(3)(6)~~ **(6)** for school year ~~2019-2020~~ **2023-2024**, and each school year
24 thereafter, the BASE aid shall be the BASE aid amount for the
25 immediately preceding school year plus an amount equal to the average
26 percentage increase in the consumer price index for all urban consumers in
27 the midwest region as published by the bureau of labor statistics of the
28 United States department of labor during the three immediately preceding
29 school years.

30 (f) "Bilingual weighting" means an addend component assigned to
31 the enrollment of school districts pursuant to K.S.A. 2017 Supp. 72-5150,
32 and amendments thereto, on the basis of costs attributable to the
33 maintenance of bilingual educational programs by such school districts.

34 (g) "Board" means the board of education of a school district.

35 (h) "Budget per student" means the general fund budget of a school
36 district divided by the enrollment of the school district.

37 (i) "Categorical fund" means and includes the following funds of a
38 school district: Adult education fund; adult supplementary education fund;
39 at-risk education fund; bilingual education fund; career and postsecondary
40 education fund; driver training fund; educational excellence grant program
41 fund; extraordinary school program fund; food service fund; parent
42 education program fund; preschool-aged at-risk education fund;
43 professional development fund; special education fund; and summer

1 program fund.

2 (j) "Cost-of-living weighting" means an addend component assigned
3 to the enrollment of school districts pursuant to K.S.A. 2017 Supp. 72-
4 5159, and amendments thereto, on the basis of costs attributable to the cost
5 of living in such school districts.

6 (k) "Current school year" means the school year during which state
7 foundation aid is determined by the state board under K.S.A. 2017 Supp.
8 72-5134, and amendments thereto.

9 ~~(l) "Declining enrollment weighting" means an addend component~~
10 ~~assigned to the enrollment of school districts pursuant to K.S.A. 2017-~~
11 ~~Supp. 72-5160, and amendments thereto, on the basis of costs attributable~~
12 ~~to the declining enrollment of such school districts.~~

13 ~~(m)~~ (l) "Enrollment" means:

14 (1) The number of students regularly enrolled in kindergarten and
15 grades one through 12 in the school district on September 20 of the
16 preceding school year plus the number of preschool-aged at-risk students
17 regularly enrolled in the school district on September 20 of the current
18 school year, except a student who is a foreign exchange student shall not
19 be counted unless such student is regularly enrolled in the school district
20 on September 20 and attending kindergarten or any of the grades one
21 through 12 maintained by the school district for at least one semester or
22 two quarters, or the equivalent thereof.

23 (2) If the enrollment in a school district in the preceding school year
24 has decreased from enrollment in the second preceding school year, the
25 enrollment of the school district in the current school year means the sum
26 of:

27 (A) The enrollment in the second preceding school year, excluding
28 students under paragraph (2)(B), minus enrollment in the preceding school
29 year of preschool-aged at-risk students, if any, plus enrollment in the
30 current school year of preschool-aged at-risk students, if any; and

31 (B) the adjusted enrollment in the second preceding school year of
32 any students participating in the tax credit for low income students
33 scholarship program pursuant to K.S.A. 2017 Supp. 72-4351 et seq., and
34 amendments thereto, in the preceding school year, if any, plus the adjusted
35 enrollment in the preceding school year of preschool-aged at-risk students
36 who are participating in the tax credit for low income students scholarship
37 program pursuant to K.S.A. 2017 Supp. 72-4351 et seq., and amendments
38 thereto, in the current school year, if any.

39 (3) For any school district that has a military student, as that term is
40 defined in K.S.A. 2017 Supp. 72-5139, and amendments thereto, enrolled
41 in such district, and that received federal impact aid for the preceding
42 school year, if the enrollment in such school district in the preceding
43 school year has decreased from enrollment in the second preceding school

1 year, the enrollment of the school district in the current school year means
2 whichever is the greater of:

3 (A) The enrollment determined under subsection (m)(2); or

4 (B) the sum of the enrollment in the preceding school year of
5 preschool-aged at-risk students, if any, and the arithmetic mean of the sum
6 of:

7 (i) The enrollment of the school district in the preceding school year
8 minus the enrollment in such school year of preschool-aged at-risk
9 students, if any;

10 (ii) the enrollment in the second preceding school year minus the
11 enrollment in such school year of preschool-aged at-risk students, if any;
12 and

13 (iii) the enrollment in the third preceding school year minus the
14 enrollment in such school year of preschool-aged at-risk students, if any.

15 ~~(4) (A) For school year 2017-2018, the enrollment determined under~~
16 ~~paragraph (1), (2) or (3), except if the school district offers kindergarten on~~
17 ~~a full-time basis in such school year, students regularly enrolled in~~
18 ~~kindergarten in the school district in the preceding school year shall be~~
19 ~~counted as one student regardless of actual attendance during such~~
20 ~~preceding school year.~~

21 ~~(B) For school year 2018-2019 and each school year thereafter, The~~
22 ~~enrollment determined under paragraph (1), (2) or (3), except if the school~~
23 ~~district begins to offer kindergarten on a full-time basis in such school~~
24 ~~year, students regularly enrolled in kindergarten in the school district in the~~
25 ~~preceding school year shall be counted as one student regardless of actual~~
26 ~~attendance during such preceding school year.~~

27 ~~(m)~~ (m) "February 20" has its usual meaning, except that in any year
28 in which February 20 is not a day on which school is maintained, it means
29 the first day after February 20 on which school is maintained.

30 ~~(n)~~ (n) "Federal impact aid" means an amount equal to the federally
31 qualified percentage of the amount of moneys a school district receives in
32 the current school year under the provisions of title I of public law 874 and
33 congressional appropriations therefor, excluding amounts received for
34 assistance in cases of major disaster and amounts received under the low-
35 rent housing program. The amount of federal impact aid shall be
36 determined by the state board in accordance with terms and conditions
37 imposed under the provisions of the public law and rules and regulations
38 thereunder.

39 ~~(o)~~ (o) "General fund" means the fund of a school district from which
40 operating expenses are paid and in which is deposited all amounts of state
41 foundation aid provided under this act, payments under K.S.A. 2017 Supp.
42 72-528, and amendments thereto, payments of federal funds made
43 available under the provisions of title I of public law 874, except amounts

1 received for assistance in cases of major disaster and amounts received
2 under the low-rent housing program and such other moneys as are
3 provided by law.

4 (†) (p) "General fund budget" means the amount budgeted for
5 operating expenses in the general fund of a school district.

6 (†) (q) "High-density at-risk student weighting" means an addend
7 component assigned to the enrollment of school districts pursuant to
8 K.S.A. 2017 Supp. 72-5151(b), and amendments thereto, on the basis of
9 costs attributable to the maintenance of at-risk educational programs by
10 such school districts.

11 (†) (r) "High enrollment weighting" means an addend component
12 assigned to the enrollment of school districts pursuant to K.S.A. 2017
13 Supp. 72-5149(b), and amendments thereto, on the basis of costs
14 attributable to maintenance of educational programs by such school
15 districts.

16 (†) (s) "Juvenile detention facility" means the same as such term is
17 defined in K.S.A. 2017 Supp. 72-1173, and amendments thereto.

18 (†) (t) "Local foundation aid" means the sum of the following
19 amounts:

20 (1) An amount equal to any unexpended and unencumbered balance
21 remaining in the general fund of the school district, except moneys
22 received by the school district and authorized to be expended for the
23 purposes specified in K.S.A. 2017 Supp. 72-5168, and amendments
24 thereto;

25 (2) an amount equal to any remaining proceeds from taxes levied
26 under authority of K.S.A. 72-7056 and 72-7072, and amendments thereto,
27 prior to their repeal;

28 (3) an amount equal to the amount deposited in the general fund in
29 the current school year from moneys received in such school year by the
30 school district under the provisions of K.S.A. 2017 Supp. 72-3123(a), and
31 amendments thereto;

32 (4) an amount equal to the amount deposited in the general fund in
33 the current school year from moneys received in such school year by the
34 school district pursuant to contracts made and entered into under authority
35 of K.S.A. 2017 Supp. 72-3125, and amendments thereto;

36 (5) an amount equal to the amount credited to the general fund in the
37 current school year from moneys distributed in such school year to the
38 school district under the provisions of articles 17 and 34 of chapter 12 of
39 the Kansas Statutes Annotated, and amendments thereto, and under the
40 provisions of articles 42 and 51 of chapter 79 of the Kansas Statutes
41 Annotated, and amendments thereto;

42 (6) an amount equal to the amount of payments received by the
43 school district under the provisions of K.S.A. 2017 Supp. 72-3423, and

1 amendments thereto;

2 (7) an amount equal to the amount of any grant received by the
3 school district under the provisions of K.S.A. 2017 Supp. 72-3425, and
4 amendments thereto; and

5 (8) an amount equal to 70% of the federal impact aid of the school
6 district.

7 ~~(v)~~ (u) "Low enrollment weighting" means an addend component
8 assigned to the enrollment of school districts pursuant to K.S.A. 2017
9 Supp. 72-5149(a), and amendments thereto, on the basis of costs
10 attributable to maintenance of educational programs by such school
11 districts.

12 ~~(w)~~ (v) "Operating expenses" means the total expenditures and lawful
13 transfers from the general fund of a school district during a school year for
14 all purposes, except expenditures for the purposes specified in K.S.A.
15 2017 Supp. 72-5168, and amendments thereto.

16 ~~(x)~~ (w) "Preceding school year" means the school year immediately
17 before the current school year.

18 ~~(y)~~ (x) "Preschool-aged at-risk student" means an at-risk student who
19 has attained the age of ~~four~~ **three** years, is under the age of eligibility for
20 attendance at kindergarten, and has been selected by the state board in
21 accordance with guidelines governing the selection of students for
22 participation in head start programs.

23 ~~(z)~~ (y) "Preschool-aged exceptional children" means exceptional
24 children, except gifted children, who have attained the age of three years
25 but are under the age of eligibility for attendance at kindergarten. The
26 terms "exceptional children" and "gifted children" have the same meaning
27 as those terms are defined in K.S.A. 2017 Supp. 72-3404, and amendments
28 thereto.

29 ~~(aa)~~ (z) "Psychiatric residential treatment facility" means the same as
30 such term is defined in K.S.A. 2017 Supp. 72-1173, and amendments
31 thereto.

32 ~~(bb)~~ (aa) "School district" means a school district organized under the
33 laws of this state that is maintaining public school for a school term in
34 accordance with the provisions of K.S.A. 2017 Supp. 72-3115, and
35 amendments thereto.

36 ~~(cc)~~ (bb) "School facilities weighting" means an added component
37 assigned to the enrollment of school districts pursuant to K.S.A. 2017
38 Supp. 72-5156, and amendments thereto, on the basis of costs attributable
39 to commencing operation of one or more new school facilities by such
40 school districts.

41 ~~(dd)~~ (cc) "School year" means the 12-month period ending June 30.

42 ~~(ee)~~ (dd) "September 20" has its usual meaning, except that in any
43 year in which September 20 is not a day on which school is maintained, it

1 means the first day after September 20 on which school is maintained.

2 ~~(ff)~~ (ee) "Special education and related services weighting" means an
3 addend component assigned to the enrollment of school districts pursuant
4 to K.S.A. 2017 Supp. 72-5157, and amendments thereto, on the basis of
5 costs attributable to the maintenance of special education and related
6 services by such school districts.

7 ~~(gg)~~ (ff) "State board" means the state board of education.

8 ~~(hh)~~ (gg) "State foundation aid" means the amount of aid distributed
9 to a school district as determined by the state board pursuant to K.S.A.
10 2017 Supp. 72-5134, and amendments thereto.

11 ~~(ii)~~ (hh) (1) "Student" means any person who is regularly enrolled in
12 a school district and attending kindergarten or any of the grades one
13 through 12 maintained by the school district or who is regularly enrolled in
14 a school district and attending kindergarten or any of the grades one
15 through 12 in another school district in accordance with an agreement
16 entered into under authority of K.S.A. 2017 Supp. 72-13,101, and
17 amendments thereto, or who is regularly enrolled in a school district and
18 attending special education services provided for preschool-aged
19 exceptional children by the school district.

20 (2) (A) Except as otherwise provided in this subsection, the following
21 shall be counted as one student:

22 (i) A student in attendance full-time; and

23 (ii) a student enrolled in a school district and attending special
24 education and related services, provided for by the school district.

25 (B) The following shall be counted as $\frac{1}{2}$ student:

26 (i) A student enrolled in a school district and attending special
27 education and related services for preschool-aged exceptional children
28 provided for by the school district; and

29 (ii) a preschool-aged at-risk student enrolled in a school district and
30 receiving services under an approved at-risk student assistance plan
31 maintained by the school district.

32 (C) A student in attendance part-time shall be counted as that
33 proportion of one student (to the nearest $\frac{1}{10}$) that the student's attendance
34 bears to full-time attendance.

35 (D) A student enrolled in and attending an institution of
36 postsecondary education that is authorized under the laws of this state to
37 award academic degrees shall be counted as one student if the student's
38 postsecondary education enrollment and attendance together with the
39 student's attendance in either of the grades 11 or 12 is at least $\frac{5}{6}$ time,
40 otherwise the student shall be counted as that proportion of one student (to
41 the nearest $\frac{1}{10}$) that the total time of the student's postsecondary education
42 attendance and attendance in grades 11 or 12, as applicable, bears to full-
43 time attendance.

1 (E) A student enrolled in and attending a technical college, a career
2 technical education program of a community college or other approved
3 career technical education program shall be counted as one student, if the
4 student's career technical education attendance together with the student's
5 attendance in any of grades nine through 12 is at least $\frac{5}{6}$ time, otherwise
6 the student shall be counted as that proportion of one student (to the
7 nearest $\frac{1}{10}$) that the total time of the student's career technical education
8 attendance and attendance in any of grades nine through 12 bears to full-
9 time attendance.

10 (F) A student enrolled in a school district and attending a non-virtual
11 school and also attending a virtual school shall be counted as that
12 proportion of one student (to the nearest $\frac{1}{10}$) that the student's attendance
13 at the non-virtual school bears to full-time attendance.

14 (G) A student enrolled in a school district and attending special
15 education and related services provided for by the school district and also
16 attending a virtual school shall be counted as that proportion of one
17 student (to the nearest $\frac{1}{10}$) that the student's attendance at the non-virtual
18 school bears to full-time attendance.

19 (H) (i) Except as provided in clause (ii), a student enrolled in a school
20 district who is not a resident of Kansas shall be counted as follows:

21 ~~(a) For school years 2017-2018 and 2018-2019, one student;~~

22 ~~(b) for school year 2019-2020 and 2020-2021, $\frac{3}{4}$ of a student; and~~

23 ~~(c) for school year 2021-2022 and each school year thereafter, $\frac{1}{2}$ of a~~
24 ~~student.~~

25 (ii) This subparagraph (H) shall not apply to:

26 ~~(a) A student whose parent or legal guardian is an employee of the~~
27 ~~school district where such student is enrolled; or~~

28 ~~(b) a student who attended public school in Kansas during school~~
29 ~~year 2016-2017 and who attended public school in Kansas during the~~
30 ~~immediately preceding school year. **A student shall not be counted if:**~~

31 ~~(a) The school such student attends is located more than eight~~
32 ~~miles from the Kansas state line by the usually traveled road; or~~

33 ~~(b) the out-of-state school district in which the student resides is~~
34 ~~adjacent to the Kansas school district in which the student is enrolled,~~
35 ~~and the out-of-state school where the student would attend is located~~
36 ~~not more than eight miles from the Kansas state line by the usually~~

38 (3) The following shall not be counted as a student:

39 (A) An individual residing at the Flint Hills job corps center;

40 (B) except as provided in subsection (ii)(2), an individual confined in
41 and receiving educational services provided for by a school district at a
42 juvenile detention facility; and

43 (C) an individual enrolled in a school district but housed, maintained

1 and receiving educational services at a state institution or a psychiatric
2 residential treatment facility.

3 (4) A student enrolled in virtual school pursuant to K.S.A. 72-3711 et
4 seq., and amendments thereto, shall be counted in accordance with the
5 provisions of K.S.A. 2017 Supp. 72-3715, and amendments thereto.

6 ~~(jj)~~ (ii) "Total foundation aid" means an amount equal to the product
7 obtained by multiplying the BASE aid by the adjusted enrollment of a
8 school district.

9 ~~(kk)~~ (jj) "Transportation weighting" means an addend component
10 assigned to the enrollment of school districts pursuant to K.S.A. 2017
