PROPONENT of HB 2498

Madam Chair Landwehr and the House Committee on Health and Human Services:

I am writing to ask you to pass HB2498 out of committee.

We are living in unprecedented times where experimental clinical trials of Covid-19 vaccine trials are being mandated. This is in violation of [FDA rules](#) and the Nuremberg code, both of which require that participation in a clinical medical trial always is voluntary. Yet, again and again, government and private mandates are promoted and court action is required to uphold constitutional rights and FDA rules.

The FDA has always, in the past, been ultra conservative with any medication for children, going through the full gamut of animal short and long term trials, then small then medium then larger human clinical trials before being released to the public. [Usually this is a ten year process.](#) Why is this different when children are at statistically no risk of hospitalization or death from Covid?

It is important for you to know that if the CDC (and subsequently the KDHE) get these vaccines on the childhood schedule, then the manufactures will have full liability protection for all ages BEFORE THEY EVER SHOW ANY LONG TERM SAFETY RESULTS! Manufacturers already have immunity through the trial because supposedly it is voluntary with full-informed consent. So why are we mandating participation in a clinical trial? This is illegal yet still happening. And I have no doubt the KDHE would **not** protect our children and ignore all those who protest, just as they have not in the past, rushing to add more and more vaccines to the Kansas schedule, if the FDA and CDC promoted this "mandate" for children as well.

Kansas Legislators needs to take a proactive and proper approach to prevent KDHE from adding this vaccine to the childhood schedule until ALL long term studies are in. Which again, will be at least a decade. Already research is proving that these vaccines [are more dangerous for children than the virus.](#) Even [MSN has posted this.](#)

MRNA vaccine research has been going on for over a decade. Unfortunately, the longer term animal studies in past trials (before 2019) showed antibody effectiveness in the first year, but long term effects on health were dismal.

Already the [mortality data for 2021 in the 18-64 age group is up 40%](#) over previous years and life insurance providers who have shared this know that the majority of these deaths are NOT from COVID. The statistical likelihood of a mere 10% increase in mortality rates in this age group would indicate something dramatic changed in our environment. To see a 40% increase in mortality is unheard of. It has to be a change in the environment that affected all 50 states. What changed? Vaccines were released and 5G was turned on. If there is something else that affected all 50 states, I am not aware of it. The science is far from settled to determine what happened! We must take steps to protect our children from these environmental changes in 2021 that resulted in this astronomical increase in adult mortality rates.

Over a decade ago, when new cancer drugs were helping with cancer but still shortening the lives of people more than the cancer would have, FDA began requiring all trials to show effectiveness to what the drug was targeting but ALSO not harming the body disproportionately more. The FDA is not following its own rules. They are not requiring Pfizer and others to prove that the vaccine does not cause other health issues as it does with all other drugs. This requirement is NOT part of these vaccine trials.

It is because of these reasons, and so many others, that legislators in Kansas must be proactive to protect our children. Please move this bill through committee and onto the floor.

The science is far from settled. It cannot be settled until time reveals their safety. Do not allow them to illegally mandate experimentation on our children!
