Chairman Hilderbrand and Senate Public Health and Welfare Committee Members,

Thank you for hearing SB 212 today! I believe it's crucial to understand the impact of failing to pass SB 212. When we are parents, we are advocates for our children: conception to death. The best way to protect children from the health crisis that's already upon us is to STOP adding vaccines to the schedule. So many of them wrecked health of patients in trials that the vaccine manufacturers quit using a scientific inert placebo in testing for safety. Instead, they removed the virus or bacteria, but left the adjuvant and other ingredients so that the injuries caused by the other toxins would damage the patient equally so manufacturers could proclaim, "SAFE!" It's just not true.

Year after year, we've heard that flu shot makers picked wrong strains of flu, rendering the shots ineffective, but still damaging to recipients due to their toxic composition. I've watched an alarming film called Vaxxed II where it follows a boy (among others) who had permanent paralysis at age 13 from the HPV/Gardasil vaccine. Ultimately, he felt such guilt for the burden he put on his parents that he committed suicide so they wouldn't have to care for him anymore. Such a shame.

Many who have vaccinated faithfully on the CDC schedule have stopped in their tracks when it came to HPV due to many reactions, including, but not limited to, being confined in a head/neck stabilizer due to new neurological disorders or becoming wheelchair bound due to paralysis.

As of March 5, VAERS (Vaccine Adverse Events Reporting System) shared that 1,198 deaths have occurred as a result of the COVID-19 vaccines. Harvard has reported that VAERS underreports dramatically: 99% of reactions and deaths are never reported. The math is alarming.

Those who promote the vaccine stand to gain significantly whether it increases job security, power reinforcement, ability to influence, or a significant amount of money. Politicians in THIS VERY BUILDING have taken money from pharmaceutical companies to stop informed consent and truth from being exposed. On the other hand, fathers and mothers have lost babies at 2, 4, and 6 months after receiving shots at their regularly scheduled checkups, only to be told it is SIDS that killed their child. Parents have battled damage to their child's intestines from the toxins in vaccines that cause encephalopathy, which is when your body sees gross motor neurons as a danger and rips apart the outer cell membrane of the neurons, which causes a child to have a diagnosis of autism. What do these parents have to gain by exposing truth about their experiences? **I urge you to seriously consider who benefits from sharing their side of the vaccine story.**

Do you own a business? If so, do you seek to give a product or a service with excellence? I imagine you do, and for what reason? Partially so you don't get sued, but partially because you want the patrons to return to you for service or product. Did you know that in 1986, President Reagan granted immunity from ALL liability for pharmaceutical companies to make vaccines as they saw fit to test or not test them? (National Childhood Vaccine Injury Act) NCVIA was

supposed to last 1-2 years, but we are beyond 30! (See film: "1986: The Act" for details.) Why would any pharma company try to guarantee safety if they cannot lose their power or money due to a flaw? Spoiler alert: they don't guarantee safety nor do they thoroughly (and ethically) test their vaccines.

It is absolutely a violation of medical freedom to require vaccinations to attend school. Although we have exemptions in Kansas, they aren't enough because we don't have TRUE informed consent. Voting in favor of this bill does NOT remove the 72 current vaccines on the KDHE's schedule. It simply restricts their powers from adding flu, HPV, COVID-19, and other vaccines. (How many vaccines did you have as a child? I'm betting nowhere near 72!)

Our great state is in no place to endure financial payouts to families due to more vaccine injuries. Our childrens' health crisis of ADHD, allergies, asthma, autism, auto-immune disorders, and more WILL bankrupt our state. When I was a child, we didn't have these issues in the classroom. If you follow the medical costs associated with caring for a child with aforementioned issues from 30 years ago, 20, 10, and today, you'll see what I'm saying is true: an explosion in these issues. What do I have to gain from sharing it? NOTHING. Why share, then? I cannot keep safety for children (and families!) a secret.

If we continue on our current trend without some checks and balances, the KDHE will not hesitate to add to the current 72-vaccines-by-18 plan: yearly flu, a series of HPV, and soon, once it's FDA approved, the COVID vaccine.
