Government Overreach remarks

I plan to speak IN PERSON with Testimony to STOP Government Overreach COVID-19 Mandates

Thank you for the opportunity to speak today.

I am deeply opposed to the blatant governmental overreach which has occurred in regard to the so called pandemic.

I have seen Covid, almost from the beginning, for what it is, a mechanism to assume even greater control over not just the USA, but the world. In retrospect, it is easy to see the decades of planning and preparation that has gone into this operation. We have been systematically conditioned and propagandized to willingly hand over our freedoms. We have been poisoned by fluoride in our water and glyphosate in our food. We have become progressively more and more wards of a "nanny" state.

A member of my family who works for the federal government has been told he must submit to an experimental medical procedure in order to keep his job. The very fact that we are having this conversation is astounding and absurd. I don't recognize our country.

To recap: it's just 2 weeks, it's just a mask, it's just your business, it's just your job, it's just your life, it's just the life of your child.

But here is the good news.

I believe that those who have committed fraud, misdeeds and malfeasance will be held accountable by a higher authority.

The great news: we stand here today in our sovereignty and in our power. We are saying no to tyranny. We are NOT waiting for top down solutions. We gather in community, we worship together, we join organizations like Kansans for Health Freedom, we are homeschooling our kids, using alternative health care focused on health, not profits, we are learning to grow our own food. We are exercising our God given, inalienable rights.

We claim our liberty and our sovereignty.
