Senate Concurrent Resolution No. 1620

A PROPOSITION to amend article 11 of the constitution of the state of 1 2 Kansas by adding a new section thereto; requiring a supermajority for 3 passage of certain bills for new or increased state taxes. 4 5 Be it resolved by the Legislature of the State of Kansas, two-thirds of the 6 members elected (or appointed) and gualified to the Senate and two-7 thirds of the members elected (or appointed) and qualified to the 8 House of Representatives concurring therein: 9 Section 1. The following proposition to amend the constitution of 10 the state of Kansas shall be submitted to the qualified electors of the state for their approval or rejection: Article 11 of the constitution of the state of 11 12 Kansas is hereby amended by adding a new section to read as follows: Supermajority for passage of certain bills for 13 "§ 14. new or increased state taxes. (a) On and after July 1, 2023, a 14 15 supermajority of two-thirds of the members then elected (or appointed) and qualified to each house, voting in the 16 affirmative, shall be necessary to pass any bill enacting or 17 amending any law creating any new state tax or increasing the 18 19 rate of any existing state income tax, sales tax, compensating 20 use tax or other excise tax, or a tax in the nature of an excise 21 tax, property tax, or a tax in the nature of a property tax, or 22 estate or inheritance tax, or a tax in the nature of an estate or 23 inheritance tax, or any combination thereof. 24 (b) In any case of a conflict between any provision of this 25 section and any other provision contained in the constitution, 26 the provisions of this section shall control." 27 Sec. 2. The following statement shall be printed on the ballot with the amendment as a whole: 28 29 "Explanatory statement. Beginning on July 1, 2023, this amendment would require a supermajority of two-thirds of 30 all members of the House of Representatives and Senate to 31 32 pass bills to enact or amend any law creating any new state tax or increasing the rate of existing state income tax, sales 33 tax, compensating use tax, other excise tax, property tax, 34 35 estate or inheritance tax or a tax in the nature of such taxes. 36 "A vote for this proposition would require a supermajority of

two-thirds of each house of the legislature to pass bills enacting or amending laws creating new state taxes or increasing the rate of existing state taxes.

"A vote against this proposition would not make any changes to 4 5 constitution and would continue the the present constitutional authority of the legislature related to vote 6 7 requirements for passage of bills." 8 This resolution, if approved by two-thirds of the members Sec. 3. elected (or appointed) and qualified to the Senate and two-thirds of the 9 members elected (or appointed) and qualified to the House of 10 Representatives, shall be entered on the journals, together with the yeas 11 and nays. The secretary of state shall cause this resolution to be published 12 as provided by law and shall cause the proposed amendment to be 13 submitted to the electors of the state at the general election in November 14 in the year 2022, unless a special election is called at a sooner date by 15 concurrent resolution of the legislature, in which case it shall be 16 submitted to the electors of the state at the special election. 17
