# **Request for bill introductions**

Chairperson Proctor called for any requests for bill introductions.

Representative Sydney Carlin requested the introduction of 24RS2320 which would add conflict of interest to Legislatures in regards to prohibiting members of Legislature from voting on matters in which they have a special interest.

Kim Borchers, Kansas Citizen requested the introduction of 24RS2527 which pertains to carving out qualifications for poll workers.

Dan Burrows, Chief Deputy Attorney General requested introduction of 24RS2679 which would amend KSA25-2438 which is the impersonating an election official statute to fix issues that have come up in recent litigation.

Clay Barker, Deputy Secretary of State, General Council requested introduction of:

The bills were accepted for introduction with no objections.

<u>Hearing on: HB2512 — Requiring advance voting ballots cast in person to be received by the county election office by 7:00 p.m. on the second day preceding the election.</u>

Chairperson Proctor opened the hearing on <u>HB2512</u> and recognized Assistant Revisor, Mike Heim, Office of Revisor of Statutes who presented overview of the bill. (<u>Attachment 1</u>).

There were no proponents of **HB2512.** 

Neutral for <u>HB2512</u> included:

Clay Barker, Deputy Secretary of State, gave testimony noting the change could cause confusion with those voters who routinely vote on the Monday before election day and were not aware of the change. (Attachment 2)

Rick Piepho, Master Certified County Clerk & Election Officer, Harvey County, gave testimony noting his office was neutral on the subject but that county election clerks would appreciate having a reduced work load the Monday before election as it is already an extremely busy day with deliveries and preparing final poll books for election day. (Attachment 3).

From the audience, Chairperson Proctor recognized Bryan Caskey, Director of Elections, Secretary of State, who responded to questions by committee members and confirmed under current law, someone who is unable to vote after the proposed 7pm deadline would only be able to vote with a provisional ballot that would not end up counting.

Chairperson Proctor opened the hearing on <u>HB2516</u> and recognized Assistant Revisor, Mike Heim, Office of Revisor of Statutes who presented overview of the bill. (<u>Attachment 10</u>).

Clay Barker, Deputy Secretary of State, voiced concern with increasing the minimum signature threshold to 25,000 and giving the election staff enough time to verify signatures and that any voter who signs an independent candidate petition may not vote in corresponding party primary which is difficult to enforce. Opponents for **HB2516** included:

Davis Hammet, Loud Light Civic Action, opposed the bill as it consolidates political party power and creates unnecessary burdens on the pursuit of public service for Kansans who reject party affiliation. (Attachment 13)
