Testimony presented to the House Transportation Committee House Bill 2680 February 14, 2024

Chairman Francis and members of the House Transportation Committee, Safe Kids Kansas is pleased to provide testimony in support of HB 2680. Safe Kids Kansas is a nonprofit coalition of partnering agencies, organizations and businesses, whose mission is to prevent unintentional injuries and injury-related death to Kansas children.

Summary of Issue and Position:

Within minutes the inside of a vehicle can reach dangerous temperatures, even on a pleasant Kansas day. A vehicle can heat up 19 degrees above the outside temperature in just the first 10 minutes, and cracking a window has very little effect on cooling the inside temperature of the vehicle. Children are at increased susceptibility from heatstroke, as their bodies heat up 3-5 times faster than an adult. For young children who may be left in a vehicle by a caregiver, this can have deadly consequences.

On average, 38 childhood heatstroke fatalities occur each year across the U.S. That's an average of one child every 10 days. In addition to heatstroke, there are other potential dangers when children are left alone in a vehicle. These hazards can include injuries from children putting the vehicle into gear, or even the possibility of a child abduction. To help prevent these tragedies and reduce the risk of injury, HB 2680 proposes penalties for drivers who intentionally leave children unattended in motor vehicles. These fines can provide a deterrent to drivers who may consider leaving children behind in the vehicle and help increase awareness of the dangers of hyperthermia and other risks to vulnerable children in vehicles. For purpose of this bill, we define vulnerable children as those ages 8 years and younger.

We know that many adults simply do not know how dangerous the inside of a parked vehicle can be and in such a short amount of time, and therefore may believe they can safely leave a child alone for "just a few minutes." As childhood safety professionals, we work to educate the public about these dangers and how to prevent tragedies and the suffering of families. HB 2680 will help to elevate awareness, penalize those who intentionally leave children unattended and place them at risk, and save the lives of Kansas children.

Never leave a child alone in a car. Remember to A-C-T.





Avoid Heatstroke

Avoid heatstroke-related injury and death by never leaving a child alone in a car, not even for a minute. And make sure to keep your car locked when you're not inside so kids don't get in on their own.





Create Reminders

Keep a stuffed animal or other memento in your child's car seat when it's empty, and move it to the front seat as a visual reminder when your child is in the back seat. Or place and secure your phone, briefcase or purse in the backseat when traveling with your child.





Take Action

If you see a child alone in a car, call 911. Emergency personnel want you to call. They are trained to respond to these situations.
