Chairman Thompson and Members of the Committee,

First, we want to thank everyone on the Senate Committee for Federal and State Affairs for your service to Kansas. We believe your role as our representatives is more important than ever in protecting our freedoms and liberty from a dysfunctional federal government that seeks to take them away. You are "our voice" to fight against this tyranny.

We hope this testimony will provide you with a clear picture of how urgent we feel this matter is. We are angry, discouraged, and afraid of what is taking place in our country. The federal government is spending this country into the ground, seizing power from the states, and taking liberty from the people. We live in constant fear and anxiety waiting for the next unconstitutional shoe to drop.

We are, however, encouraged that our founding fathers had the incredible foresight to anticipate that someday future Americans would once again face the same tyrannical overreach. They understood human nature and its thirst for power. And they knew that government would never self-limit its power. Thankfully, they provided us a mechanism, Article V in the constitution which allows states to propose amendments to address the enormous challenges we are facing today. As Kansans, WE WANT A VOICE in this amendment process!

We love this great country, but we are watching in horror at the many examples of abuse, corruption, and overreach by our federal government:

- Our national debt is over \$31 TRILLION! This is unstainable. This will enslave our children and grandchildren. This irresponsible spending by both parties in our federal government has resulted in a huge spike in inflation, job loss and rising interest rates. The government cannot tax its way out of this debt. We NEED an amendment to address fiscal restraints!
- Where is the accountability for the 100 BILLION DOLLARS sent to Ukraine? There has been NO AUDIT on how
  this money is being spent. This is the PEOPLE'S money, not the governments. We NEED an amendment to
  address fiscal restraints!
- Career politicians become more loyal to donors and special interest groups than their constituents they are supposed to be working for. Term limits are the only realistic way to change the culture of legislative careerism in Congress -- a culture that undermines the public interest. **We NEED an amendment to impose term limits!**
- Let us ask you, our representatives, a question. The last time you signed a contract, i.e., a mortgage contract, business loan, employment contract.... did you read it before signing it? Why is it ok for our federal government to pass a \$1.7 TRILLION Omnibus bill without reading it? They have been passing bills like this for years. WE HAVE A RIGHT TO KNOW WHAT IS IN THESE BILLS. PERIOD. Hidden in these bills are earmarks with strings attached. They combine grants with federal mandates giving themselves more control over the states. We NEED an amendment to restrain the power and jurisdiction of the federal government.
- Federal mandates such as Covid lockdowns and vaccines are a clear example of government overreach. We now know that vaccines were ineffective and harmful according to the CDC. The lockdowns needlessly destroyed businesses, were harmful to our children's education and damaged our economy, leading to even more government spending. This was a painful lesson to learn, and we can't ever let this happen again.

- The federal bureaucracy has placed a regulatory burden on businesses and individuals. Very little
  accountability exists when agencies, rather than Congress, determine regulations and penalties.
   We NEED an amendment to restrain the power and jurisdiction of the federal government.

It's getting increasingly worrisome that our STATE governments must constantly create bills such as SB224\* to
protect Americans from an overreaching FEDERAL government. This bill (which we support) prevents ESG
ideology from influencing banking practices and investment choices made by pensions and businesses.
 We NEED an amendment to restrain the power and jurisdiction of the federal government.

\*SB224: Enacting the Kansas protection of pensions and businesses against ideological interference act, relating to ideological boycotts involving environmental, social or governance standards, requiring KPERS to divest from and prohibiting state contracts or the deposit of state moneys with entities engaged in such boycotts as determined by the state treasurer and prohibiting discriminatory practices in the financial services industry based on such boycotts

President Biden's Department of State recently said the U.S. is "committed to a #PandemicAccord," which it
claims will "vastly improve the global health architecture for preventing, preparing for, and responding to
future pandemic emergencies." This is nothing more than one giant attempt by the WHO to create an entity
that supersedes the authority of nations, essentially creating an unspoken one world government. The WHO
would be able to violate all our rights in the name of "public health."

We NEED an amendment to restrain the power and jurisdiction of the federal government.

In closing, we could continue with example after example of why Kansas needs to pass SCR 1607, but we know your time is valuable and we trust that you will represent the almost 41,000 COS petition signers in Kansas, by passing this resolution.
