Re: Prison Bed Space Impact Assessment, SB 265 - Increasing the criminal penalties for repeat

violations of a protective order.

IMPACT ASSESSMENT

- Impact on Prison Admissions: This bill may increase prison admissions, but it cannot be determined at this time.
- **Impact on Prison Beds:** This bill **may increase** prison beds, but it cannot be determined at this time.
- Impact on the Workload of the Commission: This bill may increase journal entry workload for the Commission, but it cannot be determined at this time.

SUMMARY OF THE BILL

Section 1. K.S.A. 21-5924 is amended to add an additional penalty for **violation of a protective order**, a severity level 7, person felony upon a second or subsequent conviction. Additionally, violation of an **extended protective order** is a severity level 6, person felony, and a severity level 4, person felony upon a second or subsequent conviction.

FINDINGS

- In **CY 2022**, KBI reports **2,141** *misdemeanor* **arrests** and **28** *felony* **arrests** for **violation of a protection order** under K.S.A. 21-5924. This statute provides in pertinent part for penalties:
 - o (b)(1) Violation of a protective order is a **class A person misdemeanor**, except as provided in subsection (b)(2).
 - o (b)(2) Violation of an **extended protective order** as described in K.S.A. 60-3107(e)(2), and amendments thereto, and K.S.A. 60-31a06(d), and amendments thereto, is a **severity level 6**, **person felony**.
- In **FY 2022**, there were **2** convictions for a **felony violation of an extended protection order** under K.S.A. 21-5924. Both were **severity level 6**, **person felonies** and were sentenced to probation.

- In FY 2022, there were 129 convictions for severity level 4, person felonies.
 - **Prison 78 (60.5%)**
 - o Probation 51 (39.5%)
- In FY 2022, there were 1,229 convictions for severity level 7, person felonies.
 - **Prison 342 (27.8%)**
 - o Probation 879 (72.2%)
- The KSSC does not maintain data on misdemeanor convictions, and thus, does not have data regarding whether any of the misdemeanor convictions are second or subsequent convictions.
- Additionally, because most of the severity level seven, person felonies receive probation (72.2%), many of the second or subsequent convictions will likely receive probation.
- Because there are so few severity level 6 violations of K.S.A. 21-5924, it is likely there will be even fewer convictions at severity level 4.
- This bill may increase prison admissions, prison beds, and workload of the Commission, but it cannot be determined at this time.

IMPACT ASSESSMENT

- **Impact on Prison Admissions:** This bill **may increase** prison admissions, but it cannot be determined at this time.
- Impact on Prison Beds: This bill may increase prison beds, but it cannot be determined at this time.
- **Impact on the Workload of the Commission:** This bill **may increase** journal entry workload for the Commission, but it cannot be determined at this time.
