He stated that this bill would amend K.S.A. 19-101a to authorize counties to use home rule powers to exempt from conducting school sanitary inspections. ([Attachment 2](#)) This bill would restore the ability of Boards of County Commissioners to work with stakeholders in their community to determine whether such inspections are done by the local health officer or by others.

Final Action on HB2777.

Senator Pettey offered an amendment ([Attachment 21](#)) to Page 1, Sec 1(a), line 9 that changes verbiage from patient to "licensed" care facility and adds to Section 1, Line 13(2) "Nothing in paragraph (1) shall be construed to prohibit the state fire marshal from collecting evidentiary photographic images of any violations discovered by the state fire marshal or the state fire marshal's designee during an inspection of investigation". Discuss followed. *Senator Pettey moved her amendment, with a second from Senator O'Shea. On a voice vote of aye, the amendment was passed.* Senator Thompson offered an amendment ([Attachment 22](#)) carried on behalf of the Kansas Fire Marshall. Jenna Moyer, Staff Revisor explained the amendment.. Discussion followed. Senator Thompson moved his amendment, with a second from Senator Alley. On a voice vote of aye, the amendment failed. *Senator Pettey moved to pass **HB2777**, as amended, with a second from Senator Blasi. On a voice vote of aye, **HB2777** passed favorably, as amended.*

Final Action on HB2547

Senator Steffen offered an amendment to **HB2547** which struck the Waiver of Medical Liability. ([Attachment 23](#)) Discussion followed. *Senator Steffen moved his amendment, with a second from Senator Thompson. On a voice vote of aye, the amendment passed.* Senator Erickson offered an amendment which struck the language in Page 1, Section 1, Line 12-14. and on page 4, Line 39(4) inserted " by a school nurse, physician or mid-level practitioner". ([Attachment 24](#)) There was no discussion. *Senator Erickson moved her amendment, with a second by Senator Steffen. On a voice vote*
