Dear Chairwoman Gossage & Members of the Public Welfare Committee,

My name is Kendra Wyatt and I am the CEO of New Birth Company. I am submitting testimony in support of HB2325. New Birth Company Maternity Center is a KDHE licensed and nationally accredited birth center, located in Overland Park providing natural childbirth services to KanCare mothers from 10 Kansas Counties. HB2325 is the result of two years of diligent work with the Healthcare Stabilization Fund in response to the closure of the Kansas City Kansas birth center in July 2021 due to lack of malpractice options. KMS noted the Maternity Center's inclusion consistent with the existing corporate practice of medicine statute. This bill is not a mandate. It allows the other birth centers to operate exactly as they have been operating.

Without passing this technical fix, New Birth Company cannot meet KanCare, Tricare and the VA-CCN Managed Care Malpractice requirements. Last year we were only able to access facility malpractice through a last-minute budget reviso that expires June 30, 2023. Birth Centers are CMS mandated Medicaid services, proven to improve access to prenatal care and birth outcomes for low-risk Moms and Babies. HB2325 ensures vital access to life affirming birth facility services for KanCare Members and Kansas families.

Please support the swift passage of HB2325.

Levels of Maternity Care

After the closure of the badly needed Kansas City Kansas maternity center on July 1, 2021, we provided testimony at the Bob Bethel Oversight Committee that professional facility malpractice coverage is required by KanCare and Commercial Healthcare Insurance companies. Lack of access to affordable professional malpractice is a barrier to providing high value and affordable healthcare services for Kansas families and taxpayers. HB2325 provides access via the Healthcare Stabilization Fund to the required minimum coverage of facility malpractice. Certified Nurse Midwives are already included in the healthcare stabilization fund.
