Monica Pyles Citizen Proponent Written-Only Testimony on SB 489 Senate Committee on Public Health and Welfare

Chair Gossage and members of the Committee:

Thank you for the opportunity to provide testimony in support of the Nursery Program for Incarcerated Moms (SB 489).

My name is Monica Pyles, and I would like to share my personal story of Trauma, Incarceration and Redemption. I grew up in and out of the foster care system due to extreme sexual and physical abuse in my home. I found a way out by getting married at the age of 16 to emancipate myself. I stayed with the man I married for 12 years, we both went to the military and had three children together. I married for all the wrong reasons and although it seemed like I had done well with the cards I was dealt, I had no self-esteem and was extremely hot tempered. I never dealt with the trauma from my past and my decision making was far-fetched from healthy. I was very co-dependent and allowed some of the same abuse to repeat itself as an adult. I divorced my husband in 2010 and entered another relationship shortly after having two more children. I was overwhelmed with responsibility, working long hours as a nurse, and keeping up with all the kids. The new relationship ended quickly. I was alone and struggling. I became ill with intestinal problems and my doctor prescribed me a controlled medication. Within two weeks I can say I was addicted. I ended up abusing those two meds for 18 months and in the 18 months I was raped and was charged for the first time with a couple misdemeanors. May 2015, I allowed my ex-boyfriend and the father of my two children to come over and that decision landed me in prison for 7.5 years. I was convicted of attempted murder during a robbery gone wrong. My ex was a drug dealer and had either purchased or stolen drugs from someone. When he came to my house that person followed him there. In my flight or fight response I intervened and shot the man. After coming to prison, I thought I was going to die of a broken heart, realizing I took myself out of all 5 of my kids' lives knowing I was their only constant support. Life for the first three years in prison was hard! I found out I was pregnant again when I got to prison. I had to give birth while incarcerated, which was yet another loss. I chose a better life for my daughter by allowing a family I knew to adopt her. I stayed in contact with all my kids through visits and through programs. My ex-husband finally stepped up to be the man I wish he could have been long ago. He took care of his children and assisted with my other two. About the third year I was incarcerated I began to reach out to God. His work in me was slow at first but looking back it was and is amazing. I then reached out more for programming, and I spent hours helping the other women around me. I was finally offered to be one of the first 13 to work at the new Polo Plant at TCF where I thrived being promoted to team captain then to release and be offered a position at corporate. I was determined not to leave prison without a job! I also was determined not to leave God at the prison where I found Him!! When I was released, it was very hard to reenculture back into society after being gone for so long. I had a committed heart and a made-up mind that I not only was going to succeed but that I didn't have to go back to who I once was. I

now own my very first home which I was able to purchase only one year post release. I work part time for Brothers in Blue Reentry a faith-based program for male and female incarcerated individuals. I participate in speaking engagements to bring awareness to the needs of programming and resources for the women at TCF. Most importantly I keep God first in everything I do. He has restored my life to a level far better than I could have imagined. All the broken relationships that came from my past decision are mended. I have all my children actively in my life. This is my story, and I am very pleased to hear that there may be another resource for the women at TCF. The impact you can have when you invest in people is priceless.

I urge this committee to support the Nursery Program for Incarcerated Moms (SB 489).
