That drawing remains in my bible, reminding me now when I turn a page to it, to pray for Derek's kids.

However, I feel it is equally important to convey the significance of a bridge in Derek's name to Sumner County and his hometown of Wellington because of what I call the 'heartland heart' that is instilled in us growing up as Kansans; which is that all of our Kansas service men and women become all of our sons and daughters. Kansas is Derek's home and Kansas is the heartland of America, known for holding great honor for our service men and women who have given their lives to protect and serve our country. Derek's hometown of Wellington is the county seat of Sumner County and is well known across the state for its honor shown to our service men and women.
