16 *Be it enacted by the Legislature of the State of Kansas:*

17 *Section 1. K.S.A. 2023 Supp. 79-32,117 is hereby amended to read*
18 *as follows: 79-32,117. (a) The Kansas adjusted gross income of an*
19 *individual means such individual's federal adjusted gross income for the*
20 *taxable year, with the modifications specified in this section.*

21 *(b) There shall be added to federal adjusted gross income:*

22 *(i) Interest income less any related expenses directly incurred in the*
23 *purchase of state or political subdivision obligations, to the extent that*
24 *the same is not included in federal adjusted gross income, on obligations*
25 *of any state or political subdivision thereof, but to the extent that interest*
26 *income on obligations of this state or a political subdivision thereof*
27 *issued prior to January 1, 1988, is specifically exempt from income tax*
28 *under the laws of this state authorizing the issuance of such obligations,*
29 *it shall be excluded from computation of Kansas adjusted gross income*
30 *whether or not included in federal adjusted gross income. Interest*
31 *income on obligations of this state or a political subdivision thereof*
32 *issued after December 31, 1987, shall be excluded from computation of*
33 *Kansas adjusted gross income whether or not included in federal*
34 *adjusted gross income.*

1 (ii) *Taxes on or measured by income or fees or payments in lieu of*
2 *income taxes imposed by this state or any other taxing jurisdiction to the*
3 *extent deductible in determining federal adjusted gross income and not*
4 *credited against federal income tax. This paragraph shall not apply to*
5 *taxes imposed under the provisions of K.S.A. 79-1107 or 79-1108, and*
6 *amendments thereto, for privilege tax year 1995, and all such years*
7 *thereafter.*

8 (iii) *The federal net operating loss deduction, except that the*
9 *federal net operating loss deduction shall not be added to an individual's*
10 *federal adjusted gross income for tax years beginning after December*
11 *31, 2016.*

12 (iv) *Federal income tax refunds received by the taxpayer if the*
13 *deduction of the taxes being refunded resulted in a tax benefit for*
14 *Kansas income tax purposes during a prior taxable year. Such refunds*
15 *shall be included in income in the year actually received regardless of*
16 *the method of accounting used by the taxpayer. For purposes hereof, a*
17 *tax benefit shall be deemed to have resulted if the amount of the tax had*
18 *been deducted in determining income subject to a Kansas income tax for*
19 *a prior year regardless of the rate of taxation applied in such prior year*
20 *to the Kansas taxable income, but only that portion of the refund shall*
21 *be included as bears the same proportion to the total refund received as*
22 *the federal taxes deducted in the year to which such refund is*
23 *attributable bears to the total federal income taxes paid for such year.*
24 *For purposes of the foregoing sentence, federal taxes shall be*
25 *considered to have been deducted only to the extent such deduction does*
26 *not reduce Kansas taxable income below zero.*

27 (v) *The amount of any depreciation deduction or business expense*
28 *deduction claimed on the taxpayer's federal income tax return for any*
29 *capital expenditure in making any building or facility accessible to the*
30 *handicapped, for which expenditure the taxpayer claimed the credit*
31 *allowed by K.S.A. 79-32,177, and amendments thereto.*

32 (vi) *Any amount of designated employee contributions picked up by*
33 *an employer pursuant to K.S.A. 12-5005, 20-2603, 74-4919 and 74-4965,*
34 *and amendments thereto.*

35 (vii) *The amount of any charitable contribution made to the extent*
36 *the same is claimed as the basis for the credit allowed pursuant to K.S.A.*
37 *79-32,196, and amendments thereto.*

38 (viii) *The amount of any costs incurred for improvements to a*
39 *swine facility, claimed for deduction in determining federal adjusted*
40 *gross income, to the extent the same is claimed as the basis for any*
41 *credit allowed pursuant to K.S.A. 79-32,204, and amendments thereto.*

42 (ix) *The amount of any ad valorem taxes and assessments paid and*
43 *the amount of any costs incurred for habitat management or*

1 *construction and maintenance of improvements on real property,*
2 *claimed for deduction in determining federal adjusted gross income, to*
3 *the extent the same is claimed as the basis for any credit allowed*
4 *pursuant to K.S.A. 79-32,203, and amendments thereto.*

5 *(x) Amounts received as nonqualified withdrawals, as defined by*
6 *K.S.A. 75-643, and amendments thereto, if, at the time of contribution to*
7 *a family postsecondary education savings account, such amounts were*
8 *subtracted from the federal adjusted gross income pursuant to*
9 *subsection (c)(xv) or if such amounts are not already included in the*
10 *federal adjusted gross income.*

11 *(xi) The amount of any contribution made to the same extent the*
12 *same is claimed as the basis for the credit allowed pursuant to K.S.A. 74-*
13 *50,154, and amendments thereto.*

14 *(xii) For taxable years commencing after December 31, 2004,*
15 *amounts received as withdrawals not in accordance with the provisions*
16 *of K.S.A. 74-50,204, and amendments thereto, if, at the time of*
17 *contribution to an individual development account, such amounts were*
18 *subtracted from the federal adjusted gross income pursuant to*
19 *subsection (c)(xiii), or if such amounts are not already included in the*
20 *federal adjusted gross income.*

21 *(xiii) The amount of any expenditures claimed for deduction in*
22 *determining federal adjusted gross income, to the extent the same is*
23 *claimed as the basis for any credit allowed pursuant to K.S.A. 79-32,217*
24 *through 79-32,220 or 79-32,222, and amendments thereto.*

25 *(xiv) The amount of any amortization deduction claimed in*
26 *determining federal adjusted gross income to the extent the same is*
27 *claimed for deduction pursuant to K.S.A. 79-32,221, and amendments*
28 *thereto.*

29 *(xv) The amount of any expenditures claimed for deduction in*
30 *determining federal adjusted gross income, to the extent the same is*
31 *claimed as the basis for any credit allowed pursuant to K.S.A. 79-32,223*
32 *through 79-32,226, 79-32,228 through 79-32,231, 79-32,233 through 79-*
33 *32,236, 79-32,238 through 79-32,241, 79-32,245 through 79-32,248 or*
34 *79-32,251 through 79-32,254, and amendments thereto.*

35 *(xvi) The amount of any amortization deduction claimed in*
36 *determining federal adjusted gross income to the extent the same is*
37 *claimed for deduction pursuant to K.S.A. 79-32,227, 79-32,232, 79-*
38 *32,237, 79-32,249, 79-32,250 or 79-32,255, and amendments thereto.*

39 *(xvii) The amount of any amortization deduction claimed in*
40 *determining federal adjusted gross income to the extent the same is*
41 *claimed for deduction pursuant to K.S.A. 79-32,256, and amendments*
42 *thereto.*

43 *(xviii) For taxable years commencing after December 31, 2006, the*

1 *amount of any ad valorem or property taxes and assessments paid to a*
2 *state other than Kansas or local government located in a state other than*
3 *Kansas by a taxpayer who resides in a state other than Kansas, when the*
4 *law of such state does not allow a resident of Kansas who earns income*
5 *in such other state to claim a deduction for ad valorem or property taxes*
6 *or assessments paid to a political subdivision of the state of Kansas in*
7 *determining taxable income for income tax purposes in such other state,*
8 *to the extent that such taxes and assessments are claimed as an itemized*
9 *deduction for federal income tax purposes.*

10 *(xix) For taxable years beginning after December 31, 2012, and*
11 *ending before January 1, 2017, the amount of any: (1) Loss from*
12 *business as determined under the federal internal revenue code and*
13 *reported from schedule C and on line 12 of the taxpayer's form 1040*
14 *federal individual income tax return; (2) loss from rental real estate,*
15 *royalties, partnerships, S corporations, except those with wholly owned*
16 *subsidiaries subject to the Kansas privilege tax, estates, trusts, residual*
17 *interest in real estate mortgage investment conduits and net farm rental*
18 *as determined under the federal internal revenue code and reported*
19 *from schedule E and on line 17 of the taxpayer's form 1040 federal*
20 *individual income tax return; and (3) farm loss as determined under the*
21 *federal internal revenue code and reported from schedule F and on line*
22 *18 of the taxpayer's form 1040 federal income tax return; all to the*
23 *extent deducted or subtracted in determining the taxpayer's federal*
24 *adjusted gross income. For purposes of this subsection, references to the*
25 *federal form 1040 and federal schedule C, schedule E, and schedule F,*
26 *shall be to such form and schedules as they existed for tax year 2011,*
27 *and as revised thereafter by the internal revenue service.*

28 *(xx) For taxable years beginning after December 31, 2012, and*
29 *ending before January 1, 2017, the amount of any deduction for self-*
30 *employment taxes under section 164(f) of the federal internal revenue*
31 *code as in effect on January 1, 2012, and amendments thereto, in*
32 *determining the federal adjusted gross income of an individual taxpayer,*
33 *to the extent the deduction is attributable to income reported on schedule*
34 *C, E or F and on line 12, 17 or 18 of the taxpayer's form 1040 federal*
35 *income tax return.*

36 *(xxi) For taxable years beginning after December 31, 2012, and*
37 *ending before January 1, 2017, the amount of any deduction for*
38 *pension, profit sharing, and annuity plans of self-employed individuals*
39 *under section 62(a)(6) of the federal internal revenue code as in effect*
40 *on January 1, 2012, and amendments thereto, in determining the federal*
41 *adjusted gross income of an individual taxpayer.*

42 *(xxii) For taxable years beginning after December 31, 2012, and*
43 *ending before January 1, 2017, the amount of any deduction for health*

1 *insurance under section 162(l) of the federal internal revenue code as in*
2 *effect on January 1, 2012, and amendments thereto, in determining the*
3 *federal adjusted gross income of an individual taxpayer.*

4 *(xxiii) For taxable years beginning after December 31, 2012, and*
5 *ending before January 1, 2017, the amount of any deduction for*
6 *domestic production activities under section 199 of the federal internal*
7 *revenue code as in effect on January 1, 2012, and amendments thereto,*
8 *in determining the federal adjusted gross income of an individual*
9 *taxpayer.*

10 *(xxiv) For taxable years commencing after December 31, 2013, that*
11 *portion of the amount of any expenditure deduction claimed in*
12 *determining federal adjusted gross income for expenses paid for medical*
13 *care of the taxpayer or the taxpayer's spouse or dependents when such*
14 *expenses were paid or incurred for an abortion, or for a health benefit*
15 *plan, as defined in K.S.A. 65-6731, and amendments thereto, for the*
16 *purchase of an optional rider for coverage of abortion in accordance*
17 *with K.S.A. 40-2,190, and amendments thereto, to the extent that such*
18 *taxes and assessments are claimed as an itemized deduction for federal*
19 *income tax purposes.*

20 *(xxv) For taxable years commencing after December 31, 2013, that*
21 *portion of the amount of any expenditure deduction claimed in*
22 *determining federal adjusted gross income for expenses paid by a*
23 *taxpayer for health care when such expenses were paid or incurred for*
24 *abortion coverage, a health benefit plan, as defined in K.S.A. 65-6731,*
25 *and amendments thereto, when such expenses were paid or incurred for*
26 *abortion coverage or amounts contributed to health savings accounts for*
27 *such taxpayer's employees for the purchase of an optional rider for*
28 *coverage of abortion in accordance with K.S.A. 40-2,190, and*
29 *amendments thereto, to the extent that such taxes and assessments are*
30 *claimed as a deduction for federal income tax purposes.*

31 *(xxvi) For all taxable years beginning after December 31, 2016, the*
32 *amount of any charitable contribution made to the extent the same is*
33 *claimed as the basis for the credit allowed pursuant to K.S.A. 72-4357,*
34 *and amendments thereto, and is also claimed as an itemized deduction*
35 *for federal income tax purposes.*

36 *(xxvii) For all taxable years commencing after December 31, 2020,*
37 *the amount ~~deducted by reason of a~~ of any interest expense paid or*
38 *accrued in a previous taxable year but allowed as a deduction pursuant to*
39 *section 163 of the federal internal revenue code in the current taxable year*
40 *by reason of the carryforward of disallowed business interest pursuant to*
41 *section 163(j) of the federal internal revenue code of 1986, as in effect on*
42 *January 1, 2018. For purposes of this paragraph, an interest expense is*
43 *considered paid or accrued only in the first taxable year the deduction*

1 would have been allowable pursuant to section 163 of the federal internal
2 revenue code if the limitation pursuant to section 163(j) of the federal
3 internal revenue code did not exist.

4 (xxviii) *For all taxable years beginning after December 31, 2021,*
5 *the amount of any contributions to, or earnings from, a first-time home*
6 *buyer savings account if distributions from the account were not used to*
7 *pay for expenses or transactions authorized pursuant to K.S.A. 2023*
8 *Supp. 58-4904, and amendments thereto, or were not held for the*
9 *minimum length of time required pursuant to K.S.A. 2023 Supp. 58-*
10 *4904, and amendments thereto. Contributions to, or earnings from, such*
11 *account shall also include any amount resulting from the account*
12 *holder not designating a surviving payable on death beneficiary*
13 *pursuant to K.S.A. 2023 Supp. 58-4904(e), and amendments thereto.*

14 (c) *There shall be subtracted from federal adjusted gross income:*

15 (i) *Interest or dividend income on obligations or securities of any*
16 *authority, commission or instrumentality of the United States and its*
17 *possessions less any related expenses directly incurred in the purchase*
18 *of such obligations or securities, to the extent included in federal*
19 *adjusted gross income but exempt from state income taxes under the*
20 *laws of the United States.*

21 (ii) *Any amounts received which are included in federal adjusted*
22 *gross income but which are specifically exempt from Kansas income*
23 *taxation under the laws of the state of Kansas.*

24 (iii) *The portion of any gain or loss from the sale or other*
25 *disposition of property having a higher adjusted basis for Kansas income*
26 *tax purposes than for federal income tax purposes on the date such*
27 *property was sold or disposed of in a transaction in which gain or loss*
28 *was recognized for purposes of federal income tax that does not exceed*
29 *such difference in basis, but if a gain is considered a long-term capital*
30 *gain for federal income tax purposes, the modification shall be limited to*
31 *that portion of such gain which is included in federal adjusted gross*
32 *income.*

33 (iv) *The amount necessary to prevent the taxation under this act of*
34 *any annuity or other amount of income or gain which was properly*
35 *included in income or gain and was taxed under the laws of this state for*
36 *a taxable year prior to the effective date of this act, as amended, to the*
37 *taxpayer, or to a decedent by reason of whose death the taxpayer*
38 *acquired the right to receive the income or gain, or to a trust or estate*
39 *from which the taxpayer received the income or gain.*

40 (v) *The amount of any refund or credit for overpayment of taxes on*
41 *or measured by income or fees or payments in lieu of income taxes*
42 *imposed by this state, or any taxing jurisdiction, to the extent included in*
43 *gross income for federal income tax purposes.*

1 (vi) *Accumulation distributions received by a taxpayer as a*
2 *beneficiary of a trust to the extent that the same are included in federal*
3 *adjusted gross income.*

4 (vii) *Amounts received as annuities under the federal civil service*
5 *retirement system from the civil service retirement and disability fund*
6 *and other amounts received as retirement benefits in whatever form*
7 *which were earned for being employed by the federal government or for*
8 *service in the armed forces of the United States.*

9 (viii) *Amounts received by retired railroad employees as a*
10 *supplemental annuity under the provisions of 45 U.S.C. §§ 228b(a) and*
11 *228c(a)(1) et seq.*

12 (ix) *Amounts received by retired employees of a city and by retired*
13 *employees of any board of such city as retirement allowances pursuant*
14 *to K.S.A. 13-14,106, and amendments thereto, or pursuant to any*
15 *charter ordinance exempting a city from the provisions of K.S.A. 13-*
16 *14,106, and amendments thereto.*

17 (x) (1) *For taxable years beginning after December 31, 1976 2021,*
18 *the amount of the any federal tentative jobs tax credit disallowance*
19 *under the provisions of 26 U.S.C. § 280C(a). For taxable years ending*
20 *after December 31, 1978, the amount of the targeted jobs tax credit and*
21 *work incentive credit disallowances under 26 U.S.C. § 280C.*

22 (2) *For taxable years beginning after December 31, 2019, and*
23 *ending before January 1, 2022, the amount of the federal employee*
24 *retention credit disallowance under rules similar to the rules of 26 U.S.C.*
25 *§ 280C(a). The taxpayer shall be required to prove that such taxpayer*
26 *previously filed Kansas income tax returns and paid Kansas income tax on*
27 *the disallowed amount. Notwithstanding any other provision of law to the*
28 *contrary, any claim for refund or amended return relating to this*
29 *subparagraph shall be allowed to be filed on or before April 15, 2025, and*
30 *no claim for refund or amended return shall be allowed or filed after April*
31 *15, 2025.*

32 (xi) *For taxable years beginning after December 31, 1986, dividend*
33 *income on stock issued by Kansas venture capital, inc.*

34 (xii) *For taxable years beginning after December 31, 1989,*
35 *amounts received by retired employees of a board of public utilities as*
36 *pension and retirement benefits pursuant to K.S.A. 13-1246, 13-1246a*
37 *and 13-1249, and amendments thereto.*

38 (xiii) *For taxable years beginning after December 31, 2004,*
39 *amounts contributed to and the amount of income earned on*
40 *contributions deposited to an individual development account under*
41 *K.S.A. 74-50,201 et seq., and amendments thereto.*

42 (xiv) *For all taxable years commencing after December 31, 1996,*
43 *that portion of any income of a bank organized under the laws of this*

1 *state or any other state, a national banking association organized under*
2 *the laws of the United States, an association organized under the savings*
3 *and loan code of this state or any other state, or a federal savings*
4 *association organized under the laws of the United States, for which an*
5 *election as an S corporation under subchapter S of the federal internal*
6 *revenue code is in effect, which accrues to the taxpayer who is a*
7 *stockholder of such corporation and which is not distributed to the*
8 *stockholders as dividends of the corporation. For taxable years*
9 *beginning after December 31, 2012, and ending before January 1, 2017,*
10 *the amount of modification under this subsection shall exclude the*
11 *portion of income or loss reported on schedule E and included on line*
12 *17 of the taxpayer's form 1040 federal individual income tax return.*

13 *(xv) For all taxable years beginning after December 31, 2017, the*
14 *cumulative amounts not exceeding \$3,000, or \$6,000 for a married*
15 *couple filing a joint return, for each designated beneficiary that are*
16 *contributed to: (1) A family postsecondary education savings account*
17 *established under the Kansas postsecondary education savings program*
18 *or a qualified tuition program established and maintained by another*
19 *state or agency or instrumentality thereof pursuant to section 529 of the*
20 *internal revenue code of 1986, as amended, for the purpose of paying*
21 *the qualified higher education expenses of a designated beneficiary; or*
22 *(2) an achieving a better life experience (ABLE) account established*
23 *under the Kansas ABLE savings program or a qualified ABLE program*
24 *established and maintained by another state or agency or*
25 *instrumentality thereof pursuant to section 529A of the internal revenue*
26 *code of 1986, as amended, for the purpose of saving private funds to*
27 *support an individual with a disability. The terms and phrases used in*
28 *this paragraph shall have the meaning respectively ascribed thereto by*
29 *the provisions of K.S.A. 75-643 and 75-652, and amendments thereto,*
30 *and the provisions of such sections are hereby incorporated by reference*
31 *for all purposes thereof.*

32 *(xvi) For all taxable years beginning after December 31, 2004,*
33 *amounts received by taxpayers who are or were members of the armed*
34 *forces of the United States, including service in the Kansas army and air*
35 *national guard, as a recruitment, sign up or retention bonus received by*
36 *such taxpayer as an incentive to join, enlist or remain in the armed*
37 *services of the United States, including service in the Kansas army and*
38 *air national guard, and amounts received for repayment of educational*
39 *or student loans incurred by or obligated to such taxpayer and received*
40 *by such taxpayer as a result of such taxpayer's service in the armed*
41 *forces of the United States, including service in the Kansas army and air*
42 *national guard.*

43 *(xvii) For all taxable years beginning after December 31, 2004,*

1 *amounts received by taxpayers who are eligible members of the Kansas*
2 *army and air national guard as a reimbursement pursuant to K.S.A. 48-*
3 *281, and amendments thereto, and amounts received for death benefits*
4 *pursuant to K.S.A. 48-282, and amendments thereto, to the extent that*
5 *such death benefits are included in federal adjusted gross income of the*
6 *taxpayer.*

7 *(xviii) For the taxable year beginning after December 31, 2006,*
8 *amounts received as benefits under the federal social security act which*
9 *are included in federal adjusted gross income of a taxpayer with federal*
10 *adjusted gross income of \$50,000 or less, whether such taxpayer's filing*
11 *status is single, head of household, married filing separate or married*
12 *filing jointly; and for all taxable years beginning after December 31,*
13 *2007, amounts received as benefits under the federal social security act*
14 *which are included in federal adjusted gross income of a taxpayer with*
15 *federal adjusted gross income of \$75,000 or less, whether such*
16 *taxpayer's filing status is single, head of household, married filing*
17 *separate or married filing jointly.*

18 *(xix) Amounts received by retired employees of Washburn*
19 *university as retirement and pension benefits under the university's*
20 *retirement plan.*

21 *(xx) For taxable years beginning after December 31, 2012, and*
22 *ending before January 1, 2017, the amount of any: (1) Net profit from*
23 *business as determined under the federal internal revenue code and*
24 *reported from schedule C and on line 12 of the taxpayer's form 1040*
25 *federal individual income tax return; (2) net income, not including*
26 *guaranteed payments as defined in section 707(c) of the federal internal*
27 *revenue code and as reported to the taxpayer from federal schedule K-1,*
28 *(form 1065-B), in box 9, code F or as reported to the taxpayer from*
29 *federal schedule K-1, (form 1065) in box 4, from rental real estate,*
30 *royalties, partnerships, S corporations, estates, trusts, residual interest in*
31 *real estate mortgage investment conduits and net farm rental as*
32 *determined under the federal internal revenue code and reported from*
33 *schedule E and on line 17 of the taxpayer's form 1040 federal individual*
34 *income tax return; and (3) net farm profit as determined under the*
35 *federal internal revenue code and reported from schedule F and on line*
36 *18 of the taxpayer's form 1040 federal income tax return; all to the*
37 *extent included in the taxpayer's federal adjusted gross income. For*
38 *purposes of this subsection, references to the federal form 1040 and*
39 *federal schedule C, schedule E, and schedule F, shall be to such form*
40 *and schedules as they existed for tax year 2011 and as revised thereafter*
41 *by the internal revenue service.*

42 *(xxi) For all taxable years beginning after December 31, 2013,*
43 *amounts equal to the unreimbursed travel, lodging and medical*

1 *expenditures directly incurred by a taxpayer while living, or a dependent*
2 *of the taxpayer while living, for the donation of one or more human*
3 *organs of the taxpayer, or a dependent of the taxpayer, to another person*
4 *for human organ transplantation. The expenses may be claimed as a*
5 *subtraction modification provided for in this section to the extent the*
6 *expenses are not already subtracted from the taxpayer's federal adjusted*
7 *gross income. In no circumstances shall the subtraction modification*
8 *provided for in this section for any individual, or a dependent, exceed*
9 *\$5,000. As used in this section, "human organ" means all or part of a*
10 *liver, pancreas, kidney, intestine, lung or bone marrow. The provisions*
11 *of this paragraph shall take effect on the day the secretary of revenue*
12 *certifies to the director of the budget that the cost for the department of*
13 *revenue of modifications to the automated tax system for the purpose of*
14 *implementing this paragraph will not exceed \$20,000.*

15 *(xxii) For taxable years beginning after December 31, 2012, and*
16 *ending before January 1, 2017, the amount of net gain from the sale of:*
17 *(1) Cattle and horses, regardless of age, held by the taxpayer for draft,*
18 *breeding, dairy or sporting purposes, and held by such taxpayer for 24*
