1 AN ACT concerning roads and highways; designating ~~a portion~~ **portions**  
2 of K-96 highway as the PFC Henry Lee Fisher memorial highway **and**  
3 **the 96<sup>th</sup> Infantry Division memorial highway; designating bridge**  
4 **No. 160-96-293.72 in Sumner county as the SrA Derek Scott Martin**  
5 **memorial bridge;** amending K.S.A. 68-1044 and repealing the existing  
6 section.

8 *Be it enacted by the Legislature of the State of Kansas:*

9 New Section 1. The portion of K-96 highway from the eastern city  
10 limits of Haven to the western city limits of Haven in Reno County is  
11 hereby designated as the PFC Henry Lee Fisher memorial highway. Upon  
12 compliance with K.S.A. 68-10,114, and amendments thereto, the secretary  
13 of transportation shall place suitable signs along the highway right-of-way  
14 at proper intervals to indicate that the highway is the PFC Henry Lee  
15 Fisher memorial highway.

16 **New Sec. 2. The portion of K-96 highway from its junction with**  
17 **56<sup>th</sup> avenue then northwest on K-96 highway to its junction with**  
18 **Nickerson road in Reno county is hereby designated as the 96<sup>th</sup>**  
19 **Infantry Division memorial highway. Upon compliance with K.S.A.**  
20 **68-10,114, and amendments thereto, the secretary of transportation**  
21 **shall place suitable signs along the highway right-of-way at proper**  
22 **intervals to indicate that the highway is the 96<sup>th</sup> Infantry Division**  
23 **memorial highway.**

24 *New Sec. 3. Bridge No. 160-96-293.72 located on United States*  
25 *highway 160 in Sumner county is hereby designated as the SrA Derek*  
26 *Scott Martin memorial bridge. Upon compliance with K.S.A. 68-10,114,*  
27 *and amendments thereto, the secretary of transportation shall place*  
28 *suitable signs to indicate that such bridge is the SrA Derek Scott Martin*  
29 *memorial bridge.*

30 ~~Sec. 2.~~ **3. 4.** K.S.A. 68-1044 is hereby amended to read as follows:  
31 68-1044. K-96 highway northwest from the eastern city limits of the city  
32 of Mount Hope, then west to the *eastern* city limits of the city of *Haven,*  
33 *then west from the western city limits of Haven to the city limits of*  
34 Hutchinson is hereby designated as the state fair freeway. The secretary of

1 transportation shall place markers along the highway right-of-way at  
2 proper intervals to indicate that the highway is the state fair freeway. The  
3 secretary of transportation may accept and administer gifts and donations  
4 to aid in obtaining suitable highway signs bearing the proper approved  
5 inscription.

6       Sec. ~~3-4~~ 5. K.S.A. 68-1044 is hereby repealed.

7       Sec. ~~4-5~~ 6. This act shall take effect and be in force from and after  
8 its publication in the statute book.
