AN ACT concerning education; relating to the Kansas school equity and
 enhancement act; requiring school district enrollment to be determined
 using the current school year or preceding school year enrollment;
 requiring any school district that closed a school building in the preceding school year to use current school year enrollment; amending
 K.S.A. 2023 Supp. 72-5132 and repealing the existing section.

8 Be it enacted by the Legislature of the State of Kansas:

9 Section 1. K.S.A. 2023 Supp. 72-5132 is hereby amended to read as 10 follows: 72-5132. As used in the Kansas school equity and enhancement 11 act, K.S.A. 72-5131 et seq., and amendments thereto:

12 "Adjusted enrollment" means the enrollment of a school district, (a) excluding the remote enrollment determined pursuant to K.S.A. 2023 13 Supp. 72-5180, and amendments thereto, adjusted by adding the following 14 15 weightings, if any, to the enrollment of a school district: At-risk student weighting; bilingual weighting; career technical education weighting; 16 high-density at-risk student weighting; high enrollment weighting; low 17 18 enrollment weighting; school facilities weighting; ancillary school 19 facilities weighting; cost-of-living weighting; special education and related 20 services weighting; and transportation weighting.

(b) "Ancillary school facilities weighting" means an addend
component assigned to the enrollment of school districts pursuant to
K.S.A. 72-5158, and amendments thereto, on the basis of costs attributable
to commencing operation of one or more new school facilities by such
school districts.

(c) (1) "At-risk student" means a student who is eligible for free
meals under the national school lunch act, and who is enrolled in a school
district that maintains an approved at-risk student assistance program.

(2) "At-risk student" does not include any student enrolled in any of
the grades one through 12 who is in attendance less than full time, or any
student who is over 19 years of age. The provisions of this paragraph shall
not apply to any student who has an individualized education program.

(d) "At-risk student weighting" means an addend component assigned
to the enrollment of school districts pursuant to K.S.A. 72-5151(a), and
amendments thereto, on the basis of costs attributable to the maintenance
of at-risk educational programs by such school districts.

1 "Base aid for student excellence" or "BASE aid" means an amount (e) 2 appropriated by the legislature in a fiscal year for the designated year. The 3 amount of BASE aid shall be as follows:

(1) For school year 2018-2019, \$4,165; (2) for school year 2019-2020, \$4,436;

6 (3) for school year 2020-2021, \$4,569;

(4) for school year 2021-2022, \$4,706;

(5) for school year 2022-2023, \$4,846; and

9 (6) for school year 2023-2024, and each school year thereafter, the BASE aid shall be the BASE aid amount for the immediately preceding 10 school year plus an amount equal to the average percentage increase in the 11 consumer price index for all urban consumers in the midwest region as 12 published by the bureau of labor statistics of the United States department 13 14 of labor during the three immediately preceding school years rounded to 15 the nearest whole dollar amount.

16 "Bilingual weighting" means an addend component assigned to (f) the enrollment of school districts pursuant to K.S.A. 72-5150, and 17 18 amendments thereto, on the basis of costs attributable to the maintenance 19 of bilingual educational programs by such school districts.

"Board" means the board of education of a school district. (g)

21 "Budget per student" means the general fund budget of a school (h) 22 district divided by the enrollment of the school district.

(i) "Categorical fund" means and includes the following funds of a 23 24 school district: Adult education fund; adult supplementary education fund; 25 at-risk education fund; bilingual education fund; career and postsecondary education fund; driver training fund; educational excellence grant program 26 27 fund; extraordinary school program fund; food service fund; parent 28 education program fund; preschool-aged at-risk education fund; 29 professional development fund; special education fund; and summer 30 program fund.

31 "Cost-of-living weighting" means an addend component assigned (i) 32 to the enrollment of school districts pursuant to K.S.A. 72-5159, and 33 amendments thereto, on the basis of costs attributable to the cost of living 34 in such school districts.

35 (k) "Current school year" means the school year during which state 36 foundation aid is determined by the state board under K.S.A. 72-5134, and 37 amendments thereto.

38 (1) (1) "Enrollment" means, except as provided in K.S.A. 2023 Supp. 39 72-5180, and amendments thereto, whichever is the greater of:

40 (+)(A) The number of students regularly enrolled in kindergarten and grades one through 12 in the school district on September 20 of the 41 42 current school year plus the number of preschool-aged at-risk students 43 regularly enrolled in the school district on September 20 of the current

1 *school year;*

2 (B) except as provided in paragraph (4), the number of students 3 regularly enrolled in kindergarten and grades one through 12 in the school 4 district on September 20 of the preceding school year plus the number of preschool-aged at-risk students regularly enrolled in the school district on 5 6 September 20 of the current school year, except a student who is a foreign 7 exchange student shall not be counted unless such student is regularly-8 enrolled in the school district on September 20 and attending kindergarten 9 or any of the grades one through 12 maintained by the school district for at 10 least one semester or two quarters, or the equivalent thereof.

(2) If the enrollment in a school district in the preceding school year
 has decreased from enrollment in the second preceding school year, the
 enrollment of the school district in the current school year means the sum
 of:

(A) the enrollment in the second preceding school year, excluding
 students under paragraph (2)(B), minus enrollment in the preceding school
 year of preschool-aged at-risk students, if any, plus enrollment in the
 current school year of preschool-aged at-risk students, if any; and

19 (B) the adjusted enrollment in the second preceding school year of 20 any students participating in the tax credit for low income students-21 scholarship program pursuant to K.S.A. 72-4351 et seq., and amendments 22 thereto, in the preceding school year, if any, plus the adjusted enrollment in 23 the preceding school year of preschool-aged at-risk students who are-24 participating in the tax credit for low income students scholarship program 25 pursuant to K.S.A. 72-4351 et seq., and amendments thereto, in the current 26 school year. if any.: or

27 (3)(C) for any school district that has a military student, as that term 28 is defined in K.S.A. 72-5139, and amendments thereto, enrolled in such 29 district, and that received federal impact aid for the preceding school year, 30 if the enrollment in such school district in the preceding school year has 31 decreased from enrollment in the second preceding school year, the 32 enrollment of the school district in the current school year means 33 whichever is the greater of:

34 (A)(i) The enrollment *amounts* determined under paragraph (2)
 35 subparagraphs (A) or (B); or

(B)(*ii*) the sum of the enrollment in the preceding school year of the
 number of preschool-aged at-risk students *regularly enrolled in the school district on September 20 of the preceding school year*, if any, and the
 arithmetic mean of the sum of:

40 (i)(a) The enrollment of the number of students regularly enrolled in
41 kindergarten and grades one through 12 in the school district—in on
42 September 20 of the preceding school—year minus the enrollment in such
43 school year of preschool-aged at-risk students, if any;

(ii)(b) the enrollment in the number of students regularly enrolled in
 kindergarten and grades one through 12 in the school district on
 September 20 of the second preceding school year minus the enrollment in
 such school year of preschool-aged at-risk students, if any; and

5 (iii)(c) the enrollment in the number of students regularly enrolled in 6 kindergarten and grades one through 12 in the school district on 7 September 20 of the third preceding school year minus the enrollment in 8 such school year of preschool-aged at-risk students, if any.

9 (4)(2) The When enrollment is determined under paragraph (1), (2) or 10 (3), except if the school district begins to offer kindergarten on a full-time 11 basis in such school year, students regularly enrolled in kindergarten in the 12 school district in the preceding school year shall be counted as one student 13 regardless of actual attendance during such preceding school year.

14 (3) A foreign exchange student shall not be counted in the enrollment 15 of a school district unless such student was regularly enrolled on 16 September 20 and attending kindergarten or any of the grades one 17 through 12 maintained by the district for at least one semester or two 18 quarters, or the equivalent thereof.

(4) If a school district closed any school building that was an attendance center pursuant to K.S.A. 72-1431, and amendments thereto, in
 the preceding school year, such school district shall determine enrollment pursuant to paragraph (1)(A) in the current school year.

(m) "February 20" has its usual meaning, except that in any year in
which February 20 is not a day on which school is maintained, it means
the first day after February 20 on which school is maintained.

(n) "Federal impact aid" means an amount equal to the federally 26 27 qualified percentage of the amount of moneys a school district receives in 28 the current school year under the provisions of title I of public law 874 and 29 congressional appropriations therefor, excluding amounts received for assistance in cases of major disaster and amounts received under the low-30 31 rent housing program. The amount of federal impact aid shall be 32 determined by the state board in accordance with terms and conditions 33 imposed under the provisions of the public law and rules and regulations 34 thereunder.

(o) "General fund" means the fund of a school district from which operating expenses are paid and in which is deposited all amounts of state foundation aid provided under this act, payments under K.S.A. 72-528, and amendments thereto, payments of federal funds made available under the provisions of title I of public law 874, except amounts received for assistance in cases of major disaster and amounts received under the lowrent housing program and such other moneys as are provided by law.

42 (p) "General fund budget" means the amount budgeted for operating 43 expenses in the general fund of a school district. 1 (q) "High-density at-risk student weighting" means an addend 2 component assigned to the enrollment of school districts pursuant to 3 K.S.A. 72-5151(b), and amendments thereto, on the basis of costs 4 attributable to the maintenance of at-risk educational programs by such 5 school districts.

6 (r) "High enrollment weighting" means an addend component 7 assigned to the enrollment of school districts pursuant to K.S.A. 72-8 5149(b), and amendments thereto, on the basis of costs attributable to 9 maintenance of educational programs by such school districts.

10 (s) "Juvenile detention facility" means the same as such term is 11 defined in K.S.A. 72-1173, and amendments thereto.

(t) "Local foundation aid" means the sum of the following amounts:

(1) An amount equal to any unexpended and unencumbered balance
 remaining in the general fund of the school district, except moneys
 received by the school district and authorized to be expended for the
 purposes specified in K.S.A. 72-5168, and amendments thereto;

17 (2) an amount equal to any remaining proceeds from taxes levied 18 under authority of K.S.A. 72-7056 and 72-7072, prior to their repeal;

(3) an amount equal to the amount deposited in the general fund in
the current school year from moneys received in such school year by the
school district under the provisions of K.S.A. 72-3123(a), and amendments
thereto;

(4) an amount equal to the amount deposited in the general fund in
the current school year from moneys received in such school year by the
school district pursuant to contracts made and entered into under authority
of K.S.A. 72-3125, and amendments thereto;

(5) an amount equal to the amount credited to the general fund in the
current school year from moneys distributed in such school year to the
school district under the provisions of articles 17 and 34 of chapter 12 of
the Kansas Statutes Annotated, and amendments thereto, and under the
provisions of articles 42 and 51 of chapter 79 of the Kansas Statutes
Annotated, and amendments thereto;

(6) an amount equal to the amount of payments received by the
school district under the provisions of K.S.A. 72-3423, and amendments
thereto; and

36 (7) an amount equal to the amount of any grant received by the
37 school district under the provisions of K.S.A. 72-3425, and amendments
38 thereto.

(u) "Low enrollment weighting" means an addend component
assigned to the enrollment of school districts pursuant to K.S.A. 725149(a), and amendments thereto, on the basis of costs attributable to
maintenance of educational programs by such school districts.

43 (v) "Operating expenses" means the total expenditures and lawful

1 transfers from the general fund of a school district during a school year for

all purposes, except expenditures for the purposes specified in K.S.A. 725168, and amendments thereto.

4 (w) "Preceding school year" means the school year immediately 5 before the current school year.

6 (x) "Preschool-aged at-risk student" means an at-risk student who has 7 attained the age of three years, is under the age of eligibility for attendance 8 at kindergarten, and has been selected by the state board in accordance 9 with guidelines governing the selection of students for participation in 10 head start programs.

(y) "Preschool-aged exceptional children" means exceptional
children, except gifted children, who have attained the age of three years
but are under the age of eligibility for attendance at kindergarten.
"Exceptional children" and "gifted children" mean the same as those terms
are defined in K.S.A. 72-3404, and amendments thereto.

16 (z) "Psychiatric residential treatment facility" means the same as such 17 term is defined in K.S.A. 72-1173, and amendments thereto.

(aa) (1) "Remote enrollment" means the number of students regularly
enrolled in kindergarten and grades one through 12 in the school district
who attended school through remote learning in excess of the remote
learning limitations provided in K.S.A. 2023 Supp. 72-5180, and
amendments thereto.

23 (2) This subsection shall not apply in any school year prior to the24 2021-2022 school year.

(bb) (1) "Remote learning" means a method of providing education in which the student, although regularly enrolled in a school district, does not physically attend the attendance center such student would otherwise attend in person on a full-time basis and curriculum and instruction are prepared, provided and supervised by teachers and staff of such school district to approximate the student learning experience that would take place in the attendance center classroom.

(2) "Remote learning" does not include virtual school as such term is
 defined in K.S.A. 72-3712, and amendments thereto.

34 (3) This subsection shall not apply in any school year prior to the35 2021-2022 school year.

36 (cc) "School district" means a school district organized under the 37 laws of this state that is maintaining public school for a school term in 38 accordance with the provisions of K.S.A. 72-3115, and amendments 39 thereto.

(dd) "School facilities weighting" means an addend component
assigned to the enrollment of school districts pursuant to K.S.A. 72-5156,
and amendments thereto, on the basis of costs attributable to commencing
operation of one or more new school facilities by such school districts.

"School year" means the 12-month period ending June 30. (ee)

2 (ff) "September 20" has its usual meaning, except that in any year in which September 20 is not a day on which school is maintained, it means 3 4 the first day after September 20 on which school is maintained.

"Special education and related services weighting" means an (gg) 6 addend component assigned to the enrollment of school districts pursuant 7 to K.S.A. 72-5157, and amendments thereto, on the basis of costs 8 attributable to the maintenance of special education and related services by 9 such school districts

"State board" means the state board of education. (hh)

(ii) "State foundation aid" means the amount of aid distributed to a 11 school district as determined by the state board pursuant to K.S.A. 72-12 13 5134, and amendments thereto.

14 (jj) (1) "Student" means any person who is regularly enrolled in a school district and attending kindergarten or any of the grades one through 15 16 12 maintained by the school district or who is regularly enrolled in a 17 school district and attending kindergarten or any of the grades one through 12 in another school district in accordance with an agreement entered into 18 19 under authority of K.S.A. 72-13,101, and amendments thereto, or who is 20 regularly enrolled in a school district and attending special education 21 services provided for preschool-aged exceptional children by the school 22 district.

23 (2) (A) Except as otherwise provided in this subsection, the following 24 shall be counted as one student:

(i) A student in attendance full-time; and

(ii) a student enrolled in a school district and attending special 26 education and related services, provided for by the school district. 27

(B) The following shall be counted as $\frac{1}{2}$ student:

29 (i) A student enrolled in a school district and attending special education and related services for preschool-aged exceptional children 30 31 provided for by the school district; and

32 (ii) a preschool-aged at-risk student enrolled in a school district and 33 receiving services under an approved at-risk student assistance plan 34 maintained by the school district.

35 (C) A student in attendance part-time shall be counted as that 36 proportion of one student, to the nearest $1/_{10}$, that the student's attendance 37 bears to full-time attendance.

38 (D) A student enrolled in and attending an institution of 39 postsecondary education that is authorized under the laws of this state to award academic degrees shall be counted as one student if the student's 40 postsecondary education enrollment and attendance together with the 41 student's attendance in either of the grades 11 or 12 is at least ⁵/₆ time, 42 43 otherwise the student shall be counted as that proportion of one student, to

1 the nearest $\frac{1}{10}$, that the total time of the student's postsecondary education 2 attendance and attendance in grades 11 or 12, as applicable, bears to full-3 time attendance.

4 (E) A student enrolled in and attending a technical college, a career 5 technical education program of a community college or other approved 6 career technical education program shall be counted as one student, if the 7 student's career technical education attendance together with the student's attendance in any of grades nine through 12 is at least $\frac{5}{6}$ time, otherwise 8 the student shall be counted as that proportion of one student, to the 9 10 nearest $\frac{1}{10}$, that the total time of the student's career technical education 11 attendance and attendance in any of grades nine through 12 bears to full-12 time attendance.

13 (F) A student enrolled in a school district and attending a non-virtual 14 school and also attending a virtual school shall be counted as that 15 proportion of one student, to the nearest 1/10, that the student's attendance at 16 the non-virtual school bears to full-time attendance.

17 (G) A student enrolled in a school district and attending special 18 education and related services provided for by the school district and also 19 attending a virtual school shall be counted as that proportion of one 20 student, to the nearest 1/10, that the student's attendance at the non-virtual 21 school bears to full-time attendance.

22 (H) A student enrolled in a school district and attending school on a 23 part-time basis through remote learning and also attending school in 24 person on a part-time basis shall be counted as that proportion of one 25 student, to the nearest $1/_{10}$, that the student's in-person attendance bears to 26 full-time attendance.

27 (I) A student enrolled in a school district who is not a resident of 28 Kansas shall be counted as $\frac{1}{2}$ of a student.

This subparagraph shall not apply to:

30 (i) A student whose parent or legal guardian is an employee of the31 school district where such student is enrolled; or

(ii) a student who attended public school in Kansas during school
 year 2016-2017 and who attended public school in Kansas during the
 immediately preceding school year.

(3) The following shall not be counted as a student:

(A) An individual residing at the Flint Hills job corps center;

(B) except as provided in paragraph (2), an individual confined in and
 receiving educational services provided for by a school district at a
 juvenile detention facility; and

40 (C) an individual enrolled in a school district but housed, maintained 41 and receiving educational services at a state institution or a psychiatric 42 residential treatment facility.

(4) A student enrolled in virtual school pursuant to K.S.A. 72-3711 et

seq., and amendments thereto, shall be counted in accordance with the
 provisions of K.S.A. 72-3715, and amendments thereto.

3 (5) A student enrolled in a school district who attends school through 4 remote learning shall be counted in accordance with the provisions of this 5 section and K.S.A. 2023 Supp. 72-5180, and amendments thereto.

6 (kk) "Total foundation aid" means an amount equal to the product 7 obtained by multiplying the BASE aid by the adjusted enrollment of a 8 school district.

9 (ll) "Transportation weighting" means an addend component assigned 10 to the enrollment of school districts pursuant to K.S.A. 72-5148, and 11 amendments thereto, on the basis of costs attributable to the provision or 12 furnishing of transportation.

(mm) "Virtual school" means the same as such term is defined inK.S.A. 72-3712, and amendments thereto.

Sec. 2. K.S.A. 2023 Supp. 72-5132 is hereby repealed.

16 Sec. 3. This act shall take effect and be in force from and after its 17 publication in the statute book.
