## Testimony in Favor of SB 444 Senate Ways and Means Committee Natalie S. Bright

I am Natalie Bright and I am appearing before you on behalf of my client, the Coalition for Opportunity. For those not familiar with the Coalition for Opportunity, it is a group of Kansas businesses who employ the blind and disabled and sell products within the Kansas State Use Law program. Attached is a list of our members, their mission and the products they sell in the State Use Law Program.

The purpose of the SUL is to provide a market for the goods and services offered by disabled and blind. I have worked with many of you for several years to grow and improve the Kansas State Use Law and despite the Coalition's steadfast efforts to grow the SUL program through traditional SUL sales the program has remained fairly stagnant in growth. In addition, disabled Kansans continue to suffer from the highest unemployment rate.

This session, with the assistance of Representative Crum, SB 444 has been drafted as an incentive to engage the private sector to engage in the hiring of disabled Kansans as well as purchase goods and services from Kansas SUL vendors.
