Chairman Rhoades opened the hearing on **SB 425 – Court Fees and costs; establishing, operating and maintaining electronic filing, storage and management for Kansas Court system**

Jill Wolters, Office of the Revisor of Statutes, provided an overview of the bill (Attachment 1).

Judge James Vano, 10<sup>th</sup> Judicial District Johnson County, provided testimony as a proponent of the bill (Attachment 2), and responded to questions from committee members. He noted that the Justice Information Management System (JIMS) has been refined and integrated to include other departments, and during the first quarter of 2012, 25,461 documents were e-files. The advantage of e-filing for the public, the bar and the court system was emphasized.

Judge James Fleetwood, 18<sup>th</sup> Judicial District, Sedgwick County, provided testimony as a proponent of the bill (Attachment 3). He referred to recommended language for inclusion in the bill. He responded to questions from committee members. The cost to set-up the e-filing system is \$1.8 million, and the operation and maintenance of the system would vary year to year, he added. As requested by a committee member, he will provide additional information on the number of document filings.

Dylan Dear, Legislative Research Department, responded to questions by committee members. He stated that the FY 2012 ending balance in the Technology Fund is approximately \$880,000 and for FY 2013 will be reduced to \$670,000.

Larry Zimmerman, Kansas Credit Attorney Association, presented testimony as an opponent of the bill (Attachment 4), and noted that he was in support of the e-filing system but opposed of increased costs. He noted that Shawnee County will be moving towards a full-court and into the state-wide e-filing system. He reviewed the process to convert documents into the new system, and concern was expressed on filing surcharges on every document processed and he recommended that fees should be placed at the front-end not on every document filed.

Bob Keller, Sheriffs Association, provided neutral testimony of the bill (Attachment 5).
