Chairman opened the hearing on **HB 2780—Relating to ballot language statements**. Katherine McBride, staff revisor, gave a brief overview of the bill and responded to questions from the committee.

The Chair called on the following who spoke in support of the bill: Representative Howell (Attachment 1) and Tabitha Lehman (Attachment 2). Written testimony in support of the bill was provided by Ryan Kriegshauser of the Secretary of States Office (Attachment 3).

There were no opponents to the bill and Hearing closed on **HB 2780**.

The Chairman opened the hearing on **SB 102—Governmental ethics commission; candidate, lobbyist fee increases**. Renaë Jefferies, staff revisor, provided a overview of the bill and responded to questions from the committee.

The Chairman opened the hearing on **HB 2782–Elections; qualifications to run for public office in Kansas**. Renae Jefferies provided an explanation of the bill and responded to questions from the committee.

House Majority Leader Siegfroid appeared before the committee in support of the bill (Attachment 7) and responded to questions from the committee.

Hearing closed on **HB 2782**.

The Chair called for Final Action on **SB 17–House Substitute for SB 17 By Committee on Elections -- Relating to voter identification requirements**.

Representative Rubin moved that we amend SB 17 by substituting all the contents of SB 17 with all the language of HB 2437, as amended by House committee, with additional technical amendment. Seconded by Representative Goico. Discussion followed. Representative Rubin closed on the bill and motion carried.

Representative Rubin moved to pass **Substitute SB 17** favorably for passage as amended, seconded by Representative Goico. Discussion followed and motion carried.

The meeting adjourned at 10:45 a.m.
