The Chair noted the updated Tallgrass Congress 1 map that was originally submitted at the March 2 meeting and welcomed Dick Carter, representing the Manhattan Area Chamber of Commerce ([Attachment 1](#)).

Mr. Carter, noting that his testimony did not directly address **SB 344 – Congressional Redistricting**, although he is opposed to the bill in its present form, spoke in relation to a resolution passed by the City of Manhattan and the Riley County Commissioners to maintain Manhattan and Riley County in the Second Congressional District. He commented that keeping the city and county in the second district meshes with the redistricting guidelines to maintain common communities of interest, and he offered details to show that historically the city and county should continue to remain in the second district. Mr. Carter also included written testimony from Fred Willich, Chairman, Manhattan Area Chamber of Commerce, and two maps recommended by the chamber: Manhattan 1 and Manhattan A.

Responding to a question, Mr. Carter replied that the Antelope 1 map submitted by Representative Carlson followed the same boundary lines as Manhattan 1 and Manhattan A; the statement was verified by Representative Carlson.

The Chairman recognized Mark Green, who requested that, whatever map is chosen, the needs for accessibility for those with disabilities be considered during the deliberations.
