Chairman Taddiken welcomed the Kansas Livestock Association Leadership class to the meeting and each gave his/her name and town or county.


<u>Senator Abrams made a motion to introduce a bill to revise the Veterinary Practice Act. Senator</u> Teichman seconded the motion. Motion carried.
