The meeting was called to order by Chairman Clay Aurand at 9:00 a.m. on March 18, 2010, in Room 711 of the Docking State Office Building.

SB 359 - Special education; catastrophic state aid

Written testimony in support of **SB 359** from Kathy Cook, Special Education Director, Russell County Schools USD #407, was distributed to Committee members. (Attachment 1)

Sharon Wenger, Principal Analyst, Kansas Legislative Research Department, told Committee members that **SB 359**, as amended, ended up being the proposal the 2010 Commission recommended. Ms. Wenger advised that the threshold would be two times the prior year aid per teacher and it is based on the amount per teacher which changes based on the amount that Special Education receives. She advised it was going to be approximately a \$56,000 threshold for the current year. It eliminates "double dipping" and it would, according to Legislative Post Audit's estimate, have allowed about ten claims at a total cost of about \$420,000 for the 2009-10 school year. (Attachment 2)

A question and answer discussion among Committee members occurred.

Representative Spalding gave an explanation of a proposal for an amendment to **SB 359**. (Attachment 3)

Representative Spalding made a motion to amend SB 359 by requiring that any federal or state special education aid be deducted when computing the entitlement for catastrophic aid and add that all other provisions in current law would remain the same. The motion was seconded by Representative Roth. The motion carried by show of hands. Representatives Crow, Winn, and Flaharty requested their "no" vote be recorded.

Representative Roth made a motion to pass Representative Spalding's amendment for SB 359 and added that it would only be for the current year (2009-2010) and would revert back to the original standing as passed by the Senate. The motion was seconded by Representative Otto. The motion carried.

Chairman Aurand moved to add an amendment to SB 359 which added provisions of HB 2600, except would use the census based calculations using total enrollment of all children. The motion was seconded by Representative Brookens. The motion carried. (Attachment 4)

Representative Otto moved to pass out SB 359, as amended, favorably for passage. The motion was seconded by Representative Gordon. The motion carried.

HB 2495 - Schools; statewide levy, exemption, procedure for the elimination of

Chairman Aurand moved to pass out HB 2495 without recommendation and send the bill to the Taxation Committee. The motion was seconded by Representative Spalding. The motion failed.

Chairman Aurand told Committee members this would be the last Education Committee meeting for this session. He thanked staff members for their support and thanked Committee members for their participation.

The meeting was adjourned at 10:30 a.m.

RE: Support for Senate Bill 359 - A bill to clarify the intent of Special Education Catastrophic Aid

To: House Education Committee

Honorable Members:

I ask that you support Senate Bill 359, without amendment, and with an effective date of the current (2009-2010) school year.

I highly support that school districts would not be eligible for catastrophic state aid for expended amounts that were reimbursed or financed with state or federal special education aid.

I highly support an effective date of the current (2009-2010) school year. By May 2009, all special education agencies were well aware of the potential for a legislative clarification of the catastrophic aid formula. All FY2010 budgets should have been set with the anticipation of a more restrictive formula taking effect during the 2009-2010 school year.

I do NOT support a possible amendment that would set upper and lower limits on how much districts and special education cooperatives receive in teacher unit reimbursement, based on overall student enrollment. Special education services, by law, must be provided based on the individual need of the student. It is not uncommon for a teacher (and possibly a paraeducator) to be required for a single high-needs student, e.g. a student with severe behaviors who recently moved into a therapeutic foster care home or a student with multiple disabilities. Senate Bill 359, as passed by the Senate, allows for the flexibility needed to meet a district's ever-changing student population, as well as providing the most equitable funding for catastrophic aid.

I do NOT support a 92% cap placed on excess costs. The 92% excess cost measure is calculated as a statewide average, not a district cap. The cost of providing services to special education students will vary dramatically district-to-district, largely due to a wide disparity between salaries across the state. Also, the provision of some related services to large numbers of special education students, e.g. transportation (rather than to only those students who definitely "need" the service) also adds to a district's cost of services. It may be interesting to note that although USD 407 appears to have the highest percent of excess cost, the district also appears to receive the lowest amount of special education state aid per special education student FTE. I contend that attempting to equalize aid according to any 92% excess cost formula will provide additional funding to those districts already paying high salaries; this will, in turn, allow those districts to spend even more dollars, thus increasing the disparity even more.

In conclusion, I ask that you support Senate Bill 359, without amendment, and with an effective date of the current (2009-2010) school year.

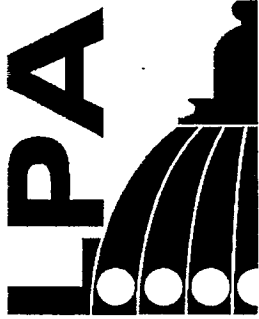

SUBJECT: Net Impact of Proposed Changes to Special Education Catastrophic Funding

During today's meeting, members had questions about the net effect Senate Bill 359 would have on the special education funding for districts and cooperatives. In the attached figure, I've pulled together estimates from Appendix C of our October 2009 report on catastrophic funding that I hope will answer some of those questions.

The figure contains three sets of estimates of the amount of catastrophic aid and teacher aid that districts and providers would receive for the 2009-10 school year. Those three sets are based on:

- **Current Law.** The catastrophic aid threshold would remain at \$25,000 and districts would continue use gross costs as the basis for aid (i.e., "double-dipping" would still be allowed).
- **Senate Bill 359.** The catastrophic aid threshold would be raised to two times the prior year's teacher aid amount (approximately \$56,000 for 2009-10) and districts would now use net costs as the basis for aid (i.e., no "double-dipping"). *[Note: These estimates don't take into account the Senate's amendment to exclude all federal funds from the catastrophic cost calculation.]*
- **Rep. Spalding's Proposal.** The catastrophic aid threshold would remain at \$25,000 and districts would now use net costs as the basis for aid (i.e., no "double-dipping").

It's important to keep in mind that these estimates are based on the assumption that districts and cooperatives can and will submit a catastrophic aid application for every student who qualifies. To the extent that they don't submit applications for all these students, the catastrophic aid estimates would be overstated (and the teacher aid estimates would be slightly understated).

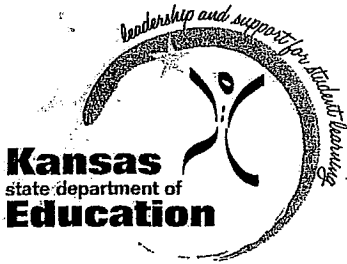
