## **Swine Feedlot Application**

Requires that facilities operating as a feedlot be licensed by the department. A feedlot is defined as a livestock feedlot, or feed yard having more than 1,000 head of livestock at one time during the license year or any other livestock feedlot whose operator elects to come under the act. This definition includes lots or pens which are not used normally for raising crops and in which no vegetation, intended for livestock feed, is growing. Swine and dairy confinement facilities are included.
