## Hearing on consideration of appointments:

Upon calling the meeting, Chairperson Susan Wagle announced this would be a hearing to consider appointments. She called upon Mr. Bill Sneed, representing the University of Kansas Hospital Authority who introduced the first conferee.

Mr. William Zollars, Chairman, President and Chief Executive Officer of Yellow Corporation provided remarks as to his background and his qualifications then stood for questions by the Committee. A question and answer discussion ensued with Senators Haley and Harrington and Ms. Mary Kruger, from the Governor's office, regarding Mr. Parkinson who had previously held a Board position. The discussion involved such issues as the Governor making the determination of terms, how long did Mr. Parkinson serve before his hiatus, and thanking him for his willingness to make the sacrifice of 4 years.
