<u>SB 52-- Emergency medical services board, financing, tax on fire insurance business, technical correction</u>

Staff briefed the committee on the bill.

David Lake, Administrator, Kansas Board of Emergency Medical Services, testified in favor of <u>SB 52</u> (<u>Attachment 1</u>). Mr. Lake explained that the bill is technical in nature for the purpose of correcting <u>Senate</u> <u>Substitute for SB 508</u> to concur with legislative intent when the bill was passed in the 2002 session.

There being no further conferees to come before the committee, the Chairman closed the public hearing on **SB 52**.

Senator Barone moved, with a second by Senator Salmans, to recommend **SB 52** favorable for passage and be placed on the Consent Calendar. Motion carried on a voice vote.

The Chairman opened the pubic hearing on:

SB 45-Application fee imposed on defendant entitled to indigent defense services

Staff briefed the committee on the bill.

Patricia Scalia, Executive Director, Kansas Board of Indigents' Defense Services, testified in favor of <u>SB 45</u> (<u>Attachment 2</u>). Ms. Scalia explained that <u>SB 45</u> would amend K.S.A. 22-4529 to require persons requesting representation by a public defender to pay an application fee of \$100.00. She mentioned that the present statute calls for an assessment of an "administrative fee" of \$35, in the discretion of the Court, as part of the court costs.

Committee questions and discussion followed. Chairman Morris discussed with Ms. Scalia about an amendment for language that makes it mandatory that would assure that the money would be collected before people are let out on bond.

There being no further conferees to come before the committee, the Chairman closed the public hearing on <u>SB 45</u>.

The Chairman opened the public hearing on:

SB 47--No employer payments for death and disability benefits during time certain
