Chairman Vickrey opened the hearing on:

## HB 2809 Unification of City of Tribune and Greeley County

Rep. Hayzlett introduced the conferees to the Committee.

Alan Peter, City/County Government Unification Action Team, testified in support of the bill (<u>Attachment</u>]). He explained that the bill would allow a study commission to be organized relating to the unification of the Greeley County Commission and the Tribune City Council.

Gary DuPree, Mayor of Tribune, testified in support of the bill (<u>Attachment 2</u>). He stated that the unification process will not eliminate any jobs but it will make the city and county governments work smoothly.

Clark Harris, testified in support of the bill (<u>Attachment 3</u>). He said that unification would allow the county and the city to continue to have separate budgets and tax bases.

Mike Thon, City/County Government Unification Action Team, testified in support of the bill (<u>Attachment</u> <u>4</u>). He said that unification recognizes that they (county/city) are one community and that there are overlapping needs.

Terry Woodbury, Kansas Communities, LLC, testified in support of the bill (<u>Attachment 5</u>). He informed that Greeley County's new "Community Building" effort was stimulated by the community's desire to reverse downward trends in the population and economy.

Rep. Miller made a motion for the favorable passage of **HB 2809** as amended. Rep. Craft seconded the motion. Motion carried.

### **HB 2667 Recreation commissions; removal of members**

Rep. Beamer testified in support of the bill (<u>Attachment 8</u>). She explained that currently, removal of members is by the appointing authority only. She said that her constituents have asked for a change to allow for petition and election.

Written testimony in support of the bill (<u>Attachment 9</u>) was submitted by Rep. Olson.

Chairman Vickrey closed the hearing on HB 2667.

### **HB 2667 Recreation commissions; removal of members**

Rep. Lane made a motion to amend the bill with clarifying language, a technical amendment. Rep. Faust-Goudeau seconded the motion. Motion carried.

Rep. Oharah made a motion for the favorable passage of **HB 2667** as amended. Rep. Lane seconded the bill. Motion carried.
