SB 39 service of process fees charged by sheriff; single payment for same case

Representative Hutchins made the motion to report **SB 39** favorably for passage. Representative Colloton seconded the motion.

Representative Hutchins made a substitute motion to exempt the same persons from paying service of process fees as those who are exempt from paying docket fees. Representative Watkins seconded the motion. The motion carried.

Representative Yoder made the motion to allow the \$5.00 service of process fee to be included in the filing fee so only one check would need to be written. Representative Davis seconded the motion. The motion failed.

Representative Hutchins made the motion to report **SB 39** favorably for passage, as amended. Representative Owens seconded the motion. The motion carried.

SB 161 - immunity from liability for entities for whom offenders perform community service

Representative Loyd made the motion to report **SB 161** favorably for passage. Representative Watkins seconded the motion.

Representative Loyd made a substitute motion to place the provision in the tort claims act and change the definition of "employee" to include private not for profit corporations or charitable or social service organizations(Attachment 1). Representative Crow seconded the motion. The motion carried.

Representative Loyd made the motion to report **SB 161** favorably for passage, as amended. Representative Owens seconded the motion. The motion carried.

SB 75 - creating liability for claims relating to obesity or weight gain

Representative Jack made the motion to report **SB 75** favorably for passage. Representative Kinzer seconded the motion.

Staff provided the committee with definitions of "food additive" and "dietary supplement" (Attachment 2).

Representative Jack made the substitute motion to include in subsection d(2) dietary supplement. Representative Kelley seconded the motion. Committee discussion centered around the fact that some dietary supplements are specifically for the purpose of weight gain and others could be consumed enough to cause other conditions. The motion failed.

Representative Davis made the motion to delete Section 1(a) and re-letter. Representative Crow seconded the motion. The motion carried.
