Chairman Sloan welcomed the Committee members and announced that today the Committee will consider a bill introduction request submitted by the Leavenworth County Attorney regarding electronic eavesdropping. Legislation

The Committee introduced two resolutions relating to the health of federal reservoirs. HCR 5012 called upon Congress to authorize and fund a study of the Missouri River Basin. HCR 5013 called upon the Assistant Secretary of the Army for Civil Works to work with the State of Kansas to extend the productive lives of reservoirs.

Both resolutions passed the House of Representatives and have been referred to the Senate Committee on Natural Resources. No additional legislation was introduced.
