Mark Schreiber, Wester (<u>Attachment 4</u>), offered neutral testimony for <u>HB 2116</u>, but noted some changes they might recommend to the wording of the bill. He commented that they do supply load and capacity information forecasts to the EPA for 10 years. Beyond that they feel the numbers are merely speculative.

Larry Holloway, Kansas Corporation Commission (<u>Attachment 5</u>), offered testimony for <u>HB 2116</u> with recommendations for language changes in the bill.

Dave Springe, CURB, (<u>Attachment 6</u>), spoke from a neutral position on <u>**HB 2116**</u>. He noted some concerns with some of the language in the bill and offered some recommendations for change.

Representative Carl Holmes asked Larry Holloway, KCC, to expand on the role of the Kansas Corporation Commission in rate making cases, and their relationship to electric utility entities. Additionally, the relationship between the KCC and the legislature was discussed.

Questions were asked and comments made by Representative Forrest Knox.

The committee was given a document created by the research department relating to state incentives that are available for energy production and transportation. (Attachment 8)

Representative Forrest Knox reminded the committee the renewables sub-committee meets tomorrow morning at 7:30 a.m.
