Chairman Donovan opened the meeting announcing we would start the meeting with the hearing on HB 2299
- Sales tax exemption for Goodwill Industries Easter Seals Society of Kansas, Inc. and Goodwill Industries of Kansas, Inc.
Bill Moore, President/CEO of Westar Energy & current board member and past Chairman of the Board for Goodwill Industries Easter Seals of Kansas, spoke in favor of this bill. He explained this bill is to restore the tax exemption statue of Goodwill Industries Easter Seals Society of Kansas, Inc. and Goodwill Industries of Kansas, Inc. (Attachment 1)
Emily Compton, President of Goodwill Industries Easter Seals of Kansas presented written testimony. (Attachment 2)

Chairman Donovan asked what the committee wishes were for this bill. Sen Steineger moved the bill be passed. Sen. Lynn seconded the motion. Schmidt moved SB 100 - Sales tax exemption for fees for guided and non-guided hunts and fishing expeditions and sale of game birds for hunting be amended into this bill also. Sen. Lynn seconded the motion. The motion passed. Then Sen. D. Schmidt moved the bill be passed as amended. Sen Lynn seconded the motion, and the motion carried.

HB 2324 - Sales tax exemption requirements for certain retail businesses under Kansas enterprise zone act was discussed. Secretary Wagnon, Department of Revenue said she and her department support this bill/Sen. Holland moved the bill be passed. Sen. Lynn seconded the motion. The motion carried.

Chairman Donovan opened the hearing on <u>SB 312 - Public utility defined for property tax purposes</u> <u>related to natural gas inventories</u>. Bill Waters, Attorney, Division of Property Valuation – Kansas Department of Revenue spoke in favor of this bill. Chairman Donovan said the bill on rebates, <u>HB 2172 - Permanent exclusion from sales taxation of certain cash rebates on sales or leases of new motor vehicles</u> has been passed back to our committee. Discussion was held. <u>Sen. D. Schmidt moved the committee pass this bill. Sen. Holland seconded the motion. The motion carried.</u>

<u>SB 242 - Computation of amount of personal property tax on motor vehicles</u> was amended in the House. <u>Sen. D. Schmidt moved we pass the bill as amended.</u> <u>Sen. Lynn seconded the motion, and the motion carried.</u>

Chairman Donovan asked the committee what they wanted to do with <u>SB 312 - Public utility defined for property tax purposes related to natural gas inventories.</u> Sen. D. Schmidt moved the bill be passed. Sen. Apple seconded the motion. The motion failed with 3 yeas and 4 nos.
