The meeting was adjourned at 1:55 p.m.



Cities that Operate PSAPs Re:

Based on the questions and comments from the Committee, we wanted to provide you with information about the cities in Kansas that operate PSAPs. There are currently 17 cities that operate PSAPs in Kansas. In most cases where a city is operating a PSAP. it is doing so because the PSAP operations have already been consolidated and the city is the entity that is providing service to the entire county. The breakdown is as follows:

# MARC Region

While there are 7 separate PSAPs in the Mid-America Regional Council Area, they are operating with significant efficiencies by working together as a region through existing interlocal agreements. These include:

Leawood, Lenexa, Leavenworth, Overland Park, Prairie Village, Shawnee, **Unified Government** 

# Arkansas City/Winfield

While there are physically two PSAPs in Cowley County, they are actively working toward consolidation.

#### Concordia

Operates a consolidated PSAP that provides service to all of Cloud County

#### **Emporia**

Operates a consolidated PSAP that provides service to all of Lyon County

## Fort Scott

Operates a consolidated PSAP that provides service to all of Bourbon County

# Garden City

Operates a consolidated PSAP that provides service to all of Finney County

#### Independence

Operates a consolidated PSAP that provides service to all of Montgomery County

#### Larned

Operates a consolidated PSAP that provides service to all of Pawnee County

### **Butler County**

There are 2 city (Andover and Augusta) PSAPs in Butler County and the County itself also operates a PSAP. These PSAPs currently serve as a backup for one another, but to date have not officially consolidated. Both the City of Augusta and the City of Andover indicate that while this has been discussed, the consolidation has been rejected to date because the city PSAP is more efficient and provides a better service than the County PSAP.

The current law sends 911 financing directly to the entities that are actually offering the 911 services in Kansas. Sending the money to counties or other entities that do not operate a PSAP may serve as a disincentive to consolidation.

For example, there is one county that has consistently asked for grant monies to build a duplicate system in an area where the entire county is already served by a city PSAP that is fully Phase II compliant. For this reason, the 911 Advisory Committee has rejected their funding requests. However, sending money directly to this county (that is not currently operating a PSAP) would give them the opportunity to set up a duplicate system. We strongly urge the Committee not to send funds to entities that are not currently operating a PSAP.

In order to achieve a greater level of efficiency, we recommend using the redistribution formula and the grant funds as methods of incentivizing consolidation and cost-sharing.
