2014 DEADLINES

The following dates are the deadlines for introduction and consideration of bills for the 2014 session. These dates were adopted as part of the Joint Rules of the Senate and House of Representatives during the 2013 Session and are subject to change.

Monday, January 13th

First day of 2014 session; convene at 2:00 p.m.

Monday, February 3rd

Last day for member or members to **REQUEST** to have bill drafted.

Monday, February 10th

Last day for <u>Committees</u> to **REQUEST** to have bills drafted except for House Appropriations, House Calendar and Printing, House Taxation, Senate Assessment and Taxation, House and Senate Federal and State Affairs, Senate Ways and Means and select committees of either chamber, when authorized.

Wednesday, February 12th

Last day for Individuals to INTRODUCE bills.

Friday, February 14th

Last day for <u>Committees</u>, except committees listed above, to **INTRODUCE** bills.

Friday, February 28th (Turnaround Day)

Last day to **CONSIDER BILLS IN HOUSE OF ORIGIN**, except by House Appropriations, House Calendar and Printing, House Taxation, Senate Assessment and Taxation, House and Senate Federal and State Affairs, Senate Ways and Means and select committees of either chamber, when authorized.

Wednesday, March 26th (Second House Consideration)

Last day to **CONSIDER BILLS NOT IN HOUSE OF ORIGIN**, except by committees listed above.

Friday, April 4th (First Adjournment)

No bills considered after this date except bills vetoed by governor, omnibus appropriations act and omnibus reconciliations spending limit bill.

Veto session normally begins 3 $\frac{1}{2}$ weeks after first adjournment. Sine Die-to be announced.
