

Declaration of No Prohibitive Offenses for KDHE Licensure

By signing this document, I declare, to the best of my knowledge, a check of the KBI criminal history database will reveal I have not been convicted of any of the listed crimes or the conviction of any of these offenses has been expunged. These offenses would prohibit me from volunteering, residing or working in a home licensed by KDHE as a family foster home. This also applies if I was adjudicated a juvenile offender for crimes which would have been a felony against persons crime if committed by an adult.
