Chairman Proehl and members of the Committee:

On behalf of our 4,977 Special Olympics athletes in Kansas, we thank you for the opportunity to share testimony for the Special Olympics Kansas license plate. Special Olympics Kansas' drive is to build communities of inclusion. We stretch into each of the 105 counties in Kansas by having 107 Local Programs. Each year, over 71 competitions are held in one of our 20 year round sports. From basketball to bowling, bocce to skiing, we are moving our athletes from the sidelines to the playing fields.

But Special Olympics Kansas is more than just sports. We are also focusing on the health, wellness, and leadership skills of our athletes. In 2017, we provided free dental screenings, vision testing and eyewear, hearing tests and overall health assessments. We also believe in our athletes leading and driving our mission.
