## SENATE BILL No. 352

AN ACT concerning education; relating to transportation funding for school districts from the state general fund; making and concerning appropriations for the fiscal year ending June 30, 2019, for the department of education; abolishing the general state aid transportation weighting - state highway fund, special education transportation weighting - state highway fund and career and technical education transportation - state highway fund of the department of education.

Be it enacted by the Legislature of the State of Kansas: Section 1.

(b) The director of accounts and reports shall not make the transfer of \$24,150,000 from the state highway fund of the department of transportation to the general state aid transportation weighting – state highway fund (652-00-2222-2222) of the department of education that was authorized to be made on July 1, 2018, October 1, 2018, January 1, 2019, and April 1, 2019, by section 2(b) of chapter 95 of the 2017 Session Laws of Kansas and, on July 1, 2018, the provisions of section 2(b) of chapter 95 of the 2017 Session Laws of Kansas that provide for such transfers are hereby declared to be null and void and shall have no force and effect.

- (c) The director of accounts and reports shall not make the transfer of \$2,500,000 from the state highway fund of the department of transportation to the special education transportation weighting state highway fund (652-00-2223-2223) of the department of education that was authorized to be made on July 1, 2018, October 1, 2018, January 1, 2019, and April 1, 2019, by section 2(b) of chapter 95 of the 2017 Session Laws of Kansas and, on July 1, 2018, the provisions of section 2(b) of chapter 95 of the 2017 Session Laws of Kansas that provide for such transfers are hereby declared to be null and void and shall have no force and effect.
- (d) The director of accounts and reports shall not make the transfer of \$650,000 from the state highway fund of the department of transportation

to the career and technical education transportation – state highway fund (652-00-2139-2139) of the department of education that was authorized to be made on July 1, 2018, October 1, 2018, January 1, 2019, and April 1, 2019, lby section 2(b) of chapter 95 of the 2017 Session Laws of Kansas and, on July 1, 2018, the provisions of section 2(b) of chapter 95 of the 2017 Session Laws of Kansas that provide for such transfers are hereby declared to be null and void and shall have no force and effect.

- (e) On July 1, 2018, the director of accounts and reports shall transfer all moneys in the general state aid transportation weighting state highway fund, special education transportation weighting state highway fund and career and technical education transportation state highway fund of the department of education to the state highway fund of the department of transportation. On July 1, 2018, all liabilities of the general state aid transportation weighting state highway fund, special education transportation weighting state highway fund and career and technical education transportation state highway fund of the department of education are hereby transferred to and imposed on the state highway fund of the department of transportation and the general state aid transportation weighting state highway fund, special education transportation weighting state highway fund and career and technical education transportation state highway fund of the department of education are hereby abolished.
- Sec. 2. Notwithstanding any other provision of law, the transportation weightings of school districts computed under the Kansas school equity and enhancement act, K.S.A. 2017 Supp. 72-5131 et seq., and amendments thereto, shall be funded from the state general fund. No appropriations or transfers shall be made during any fiscal year from the state highway fund to the department of education to pay for such transportation weightings.
- Sec. 3. This act shall take effect and be in force from and after its publication in the statute book.
