2020 Session Deadlines (Corrected)

The following dates are the anticipated deadlines for introduction and consideration of bills for the 2020 session. These deadlines were adopted as part of the Joint Rules of the Senate and House of Representatives for the 2019-2020 biennium.

Monday, February 3rd

Last day for <u>member</u> or <u>members</u> to REQUEST bill drafts from Revisor's office.

Monday, February 10th

Last day for <u>non-exempt Committees</u> to REQUEST bill drafts from the Revisor's office.

NOTE: This is the last day requests for introduction can be on nonexempt committee agendas.

Wednesday, February 12th

Last day for <u>Individuals</u> to INTRODUCE bills in originating chamber. NOTE: Bills must be submitted to chamber staff during daily session for Introduction.

Friday, February 14th

Last day for <u>non-exempt Committees</u> to INTRODUCE bills in originating chamber. NOTE: Bills must be submitted to chamber staff during daily session for Introduction.

Thursday, February 27th (Turnaround Day)

Last day to consider non-exempt bills in house of origin.

Wednesday, March 25th

Last day to consider non-exempt bills not in originating chamber.

Friday, April 3rd (First Adjournment)

No bills considered after this date except <u>bills vetoed by governor</u>, <u>omnibus appropriations act and omnibus reconciliations spending</u> <u>limit bill</u>.

Veto session is anticipated to begin on Monday, April 27th

Exempt committees: House and Senate Federal and State Affairs, Senate Ways and Means, Senate Assessment and Taxation, House committees on Calendar and Printing, Appropriations, Taxation or select committees of either house when so authorized.

Exempt bills are those sponsored by, referred to or acted upon by an exempt committee.
