AN ACT concerning motor vehicles; relating to vehicle identification
 numbers; exempting certain modifications on antique vehicles from
 vehicle identification number offense seizures and dispositions;
 amending K.S.A. 2021 Supp. 8-116 and repealing the existing section.

6 Be it enacted by the Legislature of the State of Kansas:

7 Section 1. K.S.A. 2021 Supp. 8-116 is hereby amended to read as follows: 8-116. (a) It is unlawful to sell, barter or exchange any motor 8 9 vehicle, trailer or semitrailer, the original vehicle identification number of which has been destroyed, removed, altered or defaced, except as 10 contemplated by K.S.A. 8-116a, and amendments thereto, when no part of 11 the motor vehicle, trailer or semitrailer has been stolen and a vehicle 12 identification number has been assigned to the motor vehicle according to 13 14 law. Violation of this subsection (a) is a severity level 10, nonperson 15 felony.

16 (b) It is unlawful to knowingly own or have the custody or possession 17 of a motor vehicle, trailer or semitrailer, the original vehicle identification 18 number of which has been destroyed, removed, altered or defaced, except 19 as contemplated by K.S.A. 8-116a, and amendments thereto, when no part 20 of the motor vehicle, trailer or semitrailer has been stolen and a vehicle 21 identification number has been assigned to the motor vehicle according to 22 law. Violation of this subsection-(b) is a class C *nonperson* misdemeanor.

(c) Any person who shall destroy, remove, alter or deface any vehicle
identification number, except as contemplated by K.S.A. 8-116a, and
amendments thereto, when no part of the motor vehicle, trailer or
semitrailer has been stolen, is guilty of a severity level 10, nonperson
felony.

(d) Every law enforcement officer in this state having knowledge of a
 motor vehicle, trailer or semitrailer, the vehicle identification number of
 which has been destroyed, removed, altered or defaced, shall seize and
 take possession of such motor vehicle, trailer or semitrailer.

32 (e) Every motor vehicle, trailer or semitrailer, the vehicle 33 identification number of which has been destroyed, removed, altered or 34 defaced, which *and that* has been seized under this section is an article of 35 contraband and the provisions of K.S.A. 22-2512, and amendments 36 thereto, shall apply.
