## Testimony presented to the Senate Transportation Committee Senate Bill 332 January 25, 2022

Chairman Petersen and members of the Senate Transportation Committee, Safe Kids Kansas is pleased to provide testimony in support of SB 332. Safe Kids Kansas is a nonprofit coalition of agencies, organizations and businesses dedicated to preventing unintentional injuries and death to Kansas children.

As injury prevention specialists and safety advocates we know that driving a vehicle weighing two or more tons on our roadways is a serious responsibility. The driver must not only process hundreds of tiny decisions each mile driven for their own safety, but also for the safety of others on our shared roads. In addition to the numerous distractions that take place in our vehicles, such as alerts on the dashboard, adjusting the radio and passengers, our mobile devices provide even more. Texts and notifications, music, movies, apps, video calls and even phone conversations can all divert the driver's attention away from their most important task...driving. In the matter of just a moment, the driver's attention may be pulled away from a road construction worker or a child crossing the street outside of their school putting lives at risk.

According to the National Highway Traffic Safety Administration (NHTSA), driver distraction is the leading factor in most crashes. Nearly 80% of crashes and 65% of near-crashes involve some form of distraction within three seconds before the event and distracted driving claimed 3,142 lives in 2019 alone. That was a 9.9% increase from the previous year. In Kansas, one in every four crashes are caused by distracted driving. As drivers, it is our responsibility to take caution and be aware of our surroundings. When a person is negligent in their driving responsibilities, it can result in serious or fatal consequences.

Safe Kids Kansas supports SB 332 and reasonable penalties for distracted driving behaviors to keep all individuals safe on our roads, especially in high risk areas such as construction zones and school zones.

Thank you for the opportunity to provide this testimony. We believe all children deserve the chance to grow up free from serious and disabling injuries.
