Be it enacted by the Legislature of the State of Kansas:

Section 1. In accordance with section 3 of article 6 of the constitution of the state of Kansas, the state of Kansas is divided into 10 single-member state board of education districts.

- Sec. 2. The senatorial districts referred to in sections 4 through 13 are those senatorial districts established by sections 5 through 44 of 2022 Substitute for Senate Bill No. 563.
- Sec. 3. The provisions of this act shall not affect the term of any member of the state board of education elected to represent a district at the general election of 2020 or the term of any successor to such member serving for an unexpired term. All such members shall continue to serve the districts from which elected until such members elected from the districts established by this act commence their terms of office in January of 2025.
- Sec. 4. State board of education member district one shall consist of senatorial districts 1, 4, 5 and 6.
- Sec. 5. State board of education member district two shall consist of senatorial districts 7, 8, 10 and 21.
- Sec. 6. State board of education member district three shall consist of senatorial districts 9, 11, 23 and 35.

- Sec. 8. State board of education member district five shall consist of senatorial districts 36, 38, 39 and 40.
- Sec. 9. State board of education member district six shall consist of senatorial districts 17, 20, 22 and 24.
- Sec. 10. State board of education member district seven shall consist of senatorial districts 14, 31, 33 and 34.
- Sec. 11. State board of education member district eight shall consist of senatorial districts 25, 28, 29 and 30.
- Sec. 12. State board of education member district nine shall consist of senatorial districts 12, 13, 15 and 37.

Sec. 13. State board of education member district ten shall consist of senatorial districts 16, 26, 27 and 32.

- Sec. 14. The attorney general shall certify to the secretary of state that the supreme court has entered a judgment that 2022 Substitute for Senate Bill No. 563 is a valid reapportionment of state senatorial districts. Upon receipt of such notice, the secretary of state shall cause a notice of such certification to be published in the Kansas register.
- Sec. 15. K.S.A. 2021 Supp. 4-514 and 4-526 are hereby repealed.
- Sec. 16. This act shall take effect and be in force from and after its publication in the Kansas register and the date of publication in the Kansas register of the notice prescribed in section 14.
