AN ACT concerning insurance; relating to certain group-funded insurance 1 2 pools; discontinuing payments paid to the group-funded pools fee fund and the group-funded workers' compensation fee fund; transferring 3 such balances and abolishing such funds; establishing the group-funded 4 5 pools refund fund; refunding the balance thereof and abolishing such 6 fund on July 1, 2024; amending K.S.A. 44-588 and repealing the 7 existing section; also repealing K.S.A. 12-2623 and 44-587. 8 9 Be it enacted by the Legislature of the State of Kansas: New Section 1. (a) There is hereby established in the state 10 11 treasury the group-funded pools refund fund. 12 (b) (1) Moneys in the group-funded pools refund fund shall be used only for the purpose of refunding entities that have paid into the group-13 funded pools fee fund, pursuant to K.S.A. 12-2623, prior to its repeal, and 14 the group-funded workers' compensation fee fund, pursuant to K.S.A. 44-15 587, prior to its repeal. 16 (2) Refunds shall be distributed on a pro-rata basis, based upon 17 18 premium taxes paid by each entity in the 2022 fiscal year. (3) All expenditures from the group-funded pools refund fund shall 19 be made in accordance with appropriations acts upon warrants of the 20 director of accounts and reports issued pursuant to vouchers approved by 21 the commissioner of insurance or the commissioner's designee. 22 23 (c) On July 1, 2023: (1) The director of accounts and reports shall transfer all moneys in 24 the group-funded pools fee fund, established pursuant to K.S.A. 12-2623, 25 prior to its repeal, and the group-funded workers' compensation fee fund, 26 established pursuant to K.S.A. 44-587, prior to its repeal, to the group-27 funded pools refund fund; 28 29 (2) all liabilities of the group-funded pools fee fund and the groupfunded workers' compensation fee fund are hereby transferred to and 30 imposed on the group-funded pools refund fund; and 31 (3) the group-funded pools fee fund and the group-funded workers'

32 (3) the group-funded pools fee fund and the group-funded workers'33 compensation fee fund are hereby abolished.

34 (d) On July 1, 2024, the group-funded pools refund fund is hereby35 abolished.

3	the certificate of authority provided in this act, all group-funded workers'	
4	compensation funds shall pay-no not later than 90 days after the end of	
5	each fiscal year a tax upon the annual Kansas gross premium collected by	
6	the pool at the rate of 1% per annum applied to the collective premium	
7	relating to all Kansas members of the pool for the preceding fiscal year. In	
8	the computation of the tax, all pools shall be entitled to deduct any annual	
9	Kansas gross premiums returned on account of cancellation or dividends	
10	returned to members of such pools or expenditures used for the purchase	
11	of specific and aggregate excess insurance, as provided in subsection (a) of	
12	K.S.A. $44-582(a)$, and amendments thereto.
