Good afternoon, Chairman Awercamp, distinguished committee members, and staff. Thank you for considering my testimony today.

My name is Misty Bosch-Hastings. I started working with the homeless population in 2005 after losing my father who was frequently homeless due to his mental illness, in a way to honor him. I then began working for KDADS in 2016 as the Housing and Homelessness Project Coordinator on the Behavioral Health Commission. I left this position and moved into 'boots on the ground' work at the Topeka Rescue Mission as the Director of Guest Services. In my personal time I oversee a group of 1500+ volunteers on Facebook called Volunteers Helping Topeka's Homeless. I am also a product of generational poverty and formerly homelessness myself. I say all of that to say this - I have a good eye on what is happening in homelessness not only in Topeka but also across the whole state.

Homelessness is a problem that needs to be solved; however, the piece of legislation up for debate today, House Bill 2430 (HB2430), is the wrong solution at the wrong time.

I urge the committee to understand the homeless service providers in the state are no longer working in silos but are **working together to address homelessness**. For example, Topeka has been blessed with a new city manager that is dedicated to address homelessness, and after a successful collaboration with a winter warming center in Topeka, he has planned a summit to help us all work better together. These types of collaborations are happening all over our State. **The right leaders are finally entering the right positions across our state, CoC's, and cities.** 

I understand that Kansas has invested in Housing First, I was with KDADS in 2019 when a very large sum of money was awarded for a Housing First program. I was allowed to use \$100,000 to move almost 65 individuals out of homelessness from railroad property. At last check, around 80% of those individuals were still housed.

I was also able to create a housing program at Topeka Rescue Mission that has about a 95% success rate after one year of being housed.

I respectfully urge the committee to continue to invest in Housing First and fund the agencies that are truly doing the work. I know you are aware of how effective this approach is, particularly among individuals who have experienced homelessness for long durations, and it is more cost-effective than criminalizing homelessness and promoting mass incarceration.

Ending mass homelessness is my personal and professional passion; I deeply care about ending homelessness in this state. I feel we owe it to our fellow humans to take a long, hard look at solutions that are working and, I urge the members of this committee to oppose House Bill 2430.
