1 AN ACT concerning amusement rides; relating to the Kansas amusement  
2 ride act; amending K.S.A. 40-4801 and K.S.A. 2016 Supp. 40-4802,  
3 44-1601, 44-1602, 44-1603, 44-1604, 44-1607, 44-1610, 44-1613 and  
4 44-1614 and repealing the existing sections; ~~reviving K.S.A. 2016~~

21 *Be it enacted by the Legislature of the State of Kansas:*

22

23 New Section 1. (a) No amusement ride shall be operated in this state  
24 unless a valid permit for such ride has been issued by the department. The  
25 owner of an amusement ride shall make application for a permit for such  
26 amusement ride to the secretary on such form and in such manner as  
27 prescribed by the secretary. The application for a permit shall include, but  
is not limited to, the following:

28

(1) The name of the owner and operator of the amusement ride;

29

(2) the location of the amusement ride, or the location where such  
ride is stored when not in use;

30

(3) valid certificate of inspection;

31

(4) proof of insurance; and

32

(5) certification that such ride meets the applicable ASTM  
international F24 committee standards.

(b) Each applicant shall submit a permit fee along with the

1 application in an amount as follows:

2 (1) For amusement rides erected at a permanent location, \$75 for a  
3 class A amusement ride, and \$100 for a class B amusement ride;

4 (2) for amusement rides erected at a temporary location, \$30; and

5 (3) for amusement rides owned or operated by a municipality or a  
6 nonprofit entity, whether erected at a permanent or temporary location,  
7 \$10.

8 (c) Upon approval of an application and receipt of the required fee,  
9 the secretary shall issue a permit for the amusement ride. Such permit shall  
10 be valid for one year from the date of issuance. Any permit fee paid by an  
11 applicant shall be returned to the applicant if the application is denied.

12 (d) In addition to the permit fees required under subsection (a), no  
13 amusement ride shall be operated in this state unless the owner of such  
14 ride has registered as an amusement ride owner with the department.  
15 Registration shall be valid for a period of one year. The owner of an  
16 amusement ride shall register with the department in such form and in  
17 such manner as prescribed by the secretary, and by paying a registration  
18 fee as follows:

19 (1) For amusement rides erected at a permanent location, \$500;

20 (2) for amusement rides erected at a temporary location, \$250; and

21 (3) for amusement rides owned by a municipality or nonprofit entity,  
22 whether erected at a permanent or temporary location, \$50.

23 The fee required under this subsection shall be an annual fee paid by  
24 the owner, regardless of the number of amusement rides owned by such  
25 owner.

26 (e) All fees received by the secretary pursuant to this section shall be  
27 remitted by the secretary to the state treasurer in accordance with the  
28 provisions of K.S.A. 75-4215, and amendments thereto. Upon receipt of  
29 each such remittance, the state treasurer shall deposit the entire amount in  
30 the state treasury to the credit of the amusement ride safety fund.

31 ~~(f) The provisions of this section shall be effective on and after July~~  
32 ~~1, 2018.~~

33 New Sec. 2. ~~(a)~~ There is hereby established in the state treasury the  
34 amusement ride safety fund, which shall be administered by the  
35 department of labor. The amusement ride safety fund shall consist of those  
36 moneys credited to the amusement ride safety fund pursuant to K.S.A. 44-  
37 1610 and section 1, and amendments thereto. All expenditures from the  
38 amusement ride safety fund shall be for the administration and  
39 enforcement of the Kansas amusement ride act, and shall be made in  
40 accordance with appropriation acts upon warrants of the director of  
41 accounts and reports issued pursuant to vouchers approved by the  
42 secretary, or the secretary's designee.

2 New Sec. 3. (a) (1) A patron, or a patron's parent or guardian on a  
3 patron's behalf, shall report in writing to the owner any injury sustained on  
4 an amusement ride before leaving the premises. Such report shall include:

5 (A) The name, address and phone number of the injured person;

6 (B) a full description of the incident, the injuries claimed, any  
7 treatment received and the location, date and time of the injury;

8 (C) the cause of the injury, if known; and

9 (D) the names, addresses and phone numbers of any witnesses to the  
10 incident.

11 (2) If a patron, or a patron's parent or guardian, is unable to file a  
12 report because of the severity of the patron's injuries, the patron or the  
13 patron's parent or guardian shall file the report as soon as reasonably  
14 possible.

15 (3) The owner shall prominently display signage at the point of  
16 admission or ticket sale and at least two other locations in close proximity  
17 to the amusement ride explaining a patron's duty to report injuries  
18 sustained on such amusement ride. Such signage shall include instructions  
19 on how to contact the owner's representatives if immediate assistance is  
20 needed and how to make an injury report.

21 (4) The failure of a patron, or the patron's parent or guardian, to  
22 report an injury under this subsection shall have no effect on the patron's  
23 right to commence a civil action.

24 (b) The owner of an amusement ride shall notify the department of  
25 any serious injury reported by a patron, or any injury caused by a  
26 malfunction or failure of an amusement ride or caused by an operator or  
27 patron error. Such notification shall be submitted to the department within  
28 72 hours of the time that the operator becomes aware of the injury.

29 (c) If a serious injury occurs, the equipment or conditions that caused  
30 the injury shall be preserved for the purpose of an investigation by the  
31 department and such amusement ride shall be immediately removed from  
32 service until an investigation is completed or deemed unnecessary by the  
33 secretary. Except as provided in subsection (d), if investigation of a serious  
34 injury is not commenced within 24 hours after the department receives  
35 notification of such injury, then an investigation shall be deemed  
36 unnecessary.

37 (d) If the serious injury results in the death of a patron, the owner  
38 shall notify the department of the injury as soon as possible. Such  
39 notification shall be by telephone initially with a written notification sent  
40 within 24 hours after the initial notice. If the patron's death is related to a  
41 major malfunction of the amusement ride, an investigation shall be  
42 required and the department shall commence such investigation within 24  
43 hours after receiving initial notice of the injury. No part of the amusement

1 ride or the ride itself, shall be moved or repaired without the written  
2 approval of the secretary, or the secretary's designee, except that nothing in  
3 this subsection shall be construed so as to hinder emergency response  
4 personnel from performing their duties, or to prevent the elimination of an  
5 obvious safety hazard. The owner shall provide the department with  
6 complete access to the amusement ride and all related premises for the  
7 purposes of the investigation and shall provide all information related to  
8 the cause of the injury to the department.

7 hereby amended to read as follows: 40-4802. No amusement ride shall be  
8 operated in this state unless at the time of operation the owner has in effect  
9 an insurance policy insuring the owner and operator against liability for  
10 bodily injury to persons arising out of the operation of the amusement ride.  
11 The insurance policy shall be written by an insurance company doing  
12 business in Kansas, *or by a surplus lines insurer*. Such insurance policy  
13 shall:

14 (a) Provide for coverage in an amount not less than \$1,000,000 *per*  
15 *occurrence with a \$2,000,000 annual aggregate*, except that this

23 Sec. 6. ~~On and after July 1, 2018,~~ K.S.A. 2016 Supp. 44-1601 is  
24 hereby amended to read as follows: 44-1601. As used in this act:

25 (a) (1) "Amusement ride" means any mechanical or electrical device  
26 that carries or conveys passengers along, around or over a fixed or  
27 restricted route or course or within a defined area for the purpose of giving  
28 its passengers amusement, pleasure, thrills or excitement and shall include  
29 *all rides and devices included under ASTM international F24 committee*  
30 *standards, including*, but not be limited to:

31 (A) Rides commonly known as ferris wheels, carousels, parachute  
32 towers, bungee jumping, reverse bungee jumping, tunnels of love ~~and~~,

12 use primarily by individuals aged 12 or less.

13 (d) "*Class B amusement ride*" means an amusement ride that is not  
14 classified as a class A amusement ride.

16 ~~(f)~~(f) "Home-owned amusement ride" means an amusement ride  
17 owned by a ~~not-for-profit entity~~ *an individual* and operated:

37 ~~(j)~~(j) "Parent or guardian" means any parent, guardian or custodian  
38 responsible for the control, safety, training or education of a minor or an  
39 adult or minor with an impairment in need of a guardian or a conservator,  
40 or both, as those terms are defined by K.S.A. 59-3051, and amendments

11 hereby amended to read as follows: 44-1602. (a) ~~The secretary shall adopt~~  
12 ~~rules and regulations specifying programs that issue certification or other~~  
13 ~~evidence of qualification to inspect amusement rides and that the secretary~~  
14 ~~determines require education, experience and training at least equivalent to~~  
15 ~~those required on the effective date of this act for a level 1 certification by~~  
16 ~~the national association of amusement ride safety officials. The secretary~~

6 ride shall retain at all times current ~~maintenance and inspection~~ records  
7 *relating to the construction, repair and maintenance of its operation,*  
8 *including safety, inspection, maintenance records and ride operator*  
9 *training activities for such ride. Such records shall be available to any*  
10 *person contracting with the owner for the amusement ride's operation, and*  
11 *shall be made available to the department at reasonable times, including*  
12 *during an inspection upon the department's request. Records of daily*  
13 *inspections must be available for inspection at the location where the ride*  
14 *or device is operated. All records must be maintained for a period of three*
