

**HOUSE BILL No. 2241**

1 AN ACT concerning insurance; relating to health insurance plans;  
2 providing requirements for coverage of diagnostic examinations for  
3 breast cancer; amending K.S.A. 2020 Supp. 40-2,103 and 40-19c09 and  
4 repealing the existing sections.

6 *Be it enacted by the Legislature of the State of Kansas:*

7 New Section 1. (a) Every individual or group health insurance policy,  
8 medical service plan, contract, hospital service corporation contract,  
9 hospital and medical service corporation contract, fraternal benefit society  
10 or health maintenance organization that provides coverage for accident and  
11 health services that is delivered, issued for delivery, amended or renewed  
12 on or after January 1, 2022, and that provides benefits for diagnostic  
13 examinations for breast cancer shall ensure that the cost-sharing  
14 requirements and treatment limitations that are applicable to a diagnostic  
15 examination for breast cancer are not less favorable for an insured than  
16 such requirements and limitations that apply to a screening examination  
17 for breast cancer for such insured.

18 (b) The provisions of K.S.A. 40-2248 and 40-2249a, and amendments  
19 thereto, shall not apply to this section.

20 (c) As used in this section:

21 (1) "Cost-sharing requirements" means any deductible, coinsurance,  
22 copayment or any maximum limitation on the application of a deductible,  
23 coinsurance, copayment or similar out-of-pocket expense.

24 (2) "Diagnostic examination for breast cancer" means a medically  
25 necessary and appropriate examination, as determined by a duly  
26 authorized healthcare professional treating the insured, for breast cancer to  
27 evaluate an abnormality in the breast that is:

28 (A) Seen or suspected from a screening examination for breast  
29 cancer;

30 (B) detected by another means of examination; or

31 (C) suspected based on the medical or family medical history of the  
32 individual.

33 (3) "Screening examination for breast cancer" means an examination  
34 used to evaluate an abnormality in a breast using diagnostic  
35 mammography or magnetic resonance imaging or ultrasound of the breast.

5 *and section 1*, *and amendments thereto*, shall apply to all insurance  
6 policies, subscriber contracts or certificates of insurance delivered,  
7 renewed or issued for delivery within or outside of this state or used within  
8 this state by or for an individual who resides or is employed in this state.

10 follows: 40-19c09. (a) Corporations organized under the nonprofit medical  
11 and hospital service corporation act shall be subject to the provisions of  
12 the Kansas general corporation code, articles 60 through 74 of chapter 17  
13 of the Kansas Statutes Annotated, and amendments thereto, applicable to  
14 nonprofit corporations, to the provisions of K.S.A. 40-214, 40-215, 40-  
15 216, 40-218, 40-219, 40-222, 40-223, 40-224, 40-225, 40-229, 40-230, 40-  
16 231, 40-235, 40-236, 40-237, 40-247, 40-248, 40-249, 40-250, 40-251, 40-  
17 252, 40-2,100, 40-2,101, 40-2,102, 40-2,103, 40-2,104, 40-2,105, 40-  
18 2,116, 40-2,117, 40-2,125, 40-2,153, 40-2,154, 40-2,160, 40-2,161, 40-

24 40-2,216 *and section 1*, *and amendments thereto*, except as the context  
25 otherwise requires, and shall not be subject to any other provisions of the  
26 insurance code except as expressly provided in this act.

27 (b) No policy, agreement, contract or certificate issued by a  
28 corporation to which this section applies shall contain a provision which  
29 excludes, limits or otherwise restricts coverage because medicaid benefits  
30 as permitted by title XIX of the social security act of 1965 are or may be  
31 available for the same accident or illness.

32 (c) Violation of subsection (b) shall be subject to the penalties  
33 prescribed by K.S.A. 40-2407 and 40-2411, and amendments thereto.

34 Sec. 4. K.S.A. 2020 Supp. 40-2,103 and 40-19c09 are hereby  
35 repealed.

36 Sec. 5. This act shall take effect and be in force from and after its  
37 publication in the statute book.
