5 removing certain exemptions from the open records act for certain  
6 business tax records no longer required to be filed; UCC filings with  
7 improperly included social security numbers; other filing or  
8 information requirements; filing fees; repealing certain obsolete statutes  
9 including relating to blanket music licenses; **publication and**  
10 **distribution of session laws, the Kansas register, proposed**  
11 **amendments to the constitution of the state of Kansas and Kansas**  
12 **administrative rules and regulations; permitting use of printing and**
